to use the waters of the DESCHUTES RIVER, a tributary of the COLUMBIA RIVER, for the purpose of IRRIGATING 0.47 ACRE.

The right to be transferred was confirmed by decree of the Circuit Court of the State of Oregon for DESCHUTES County as evidenced by certificate 29054 and a portion subsequently changed under transfer 3262. The decree is recorded in the Order Record of the WATER RESOURCES DIRECTOR in Volume 16, at page 164. The date of priority is September 1, 1899.

The point of diversion is located as follows:

SE 1/4 NE 1/4, SECTION 29, T 17 S, R 12 E, W.M.; SWALLEY CANAL - 1620 FEET SOUTH AND 600 FEET WEST FROM THE NE CORNER OF SECTION 29.

A description of the new place of use is as follows:

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 1991.
- 2. The following former place of use shall no longer be irrigated as a part of this water right:

SW 1/4 SW 1/4 0.47 ACRE SECTION 3 TOWNSHIP 17 SOUTH, RANGE 12 EAST, W.M.

When proof to the satisfaction of the Water Resources Director of the completed change is received, the change shall be considered perfected. At a later date, a new certificate shall be issued to the Swalley Irrigation District confirming this and other changes within the District.
