On August 14, 2012, the Water Resources Department issued a Final Order in other than a Contested Case described as Certificate of Water Right Number 86975. The Certificate confirmed the extent of use of water perfected under the terms of Transfer T-7643.

## **Findings of Fact**

- 1. On November 8, 1999, the Department issued Special Order Volume 53, Pages 1403-1406, approving Transfer T-7643. On December 16, 1999, the Department issued Special Order Volume 53, Pages 1484-1485, amending the Transfer T-7643 approval order issued on November 8, 1999.
- On March 26, 2008, Water Right Certificate 84012 was issued to confirm that the changes authorized under Special Order Volume 53, Pages 1403-1406 and Special Order Volume 53, Pages 1484-1485, Transfer T-7643, were completed.
  - 3. On August July 7, 2009, Water Right Certificate 85665 was issued to supersede Certificate 84012 correcting a scrivener's error in the listing of the place of use and to confirm the orders of Special Order Volume 53, Pages 1403-1406 and Special Order Volume 53, Pages 1484-1485, approving Transfer T-7643.
  - 4. On August 14, 2012, the Department issued a *second* certificate, Water Right Certificate 86975, confirming the changes authorized under Special Order Volume 53, Pages 1403-1406 and Special Order Volume 53, Pages 1484-1485, Transfer T-7643.
  - 5. The Department has determined that a Certificate 85665 was properly issued to confirm changes completed under Transfer T-7643, and that Certificate 86975 was issued in error.

## NOTICE OF RIGHT TO RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

## Now, therefore, it is ORDERED:

- 1. Water Right Certificate 86975 is hereby withdrawn.
- 2. Final Order Certificate Number 86975 is of no further force or effect.
