ORDER APPROVING AN ADDITIONAL POINT OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and concerns resolved, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6559 submitted by

MOUNT ANGEL ABBEY  
SAINT BENEDICT, OREGON 97373.

The right to be modified, as evidenced by Certificate 45199, was perfected under Permit G-5372 with a date of priority of MARCH 17, 1971. The right allows the use of A WELL, a tributary of ABIQUA CREEK BASIN, for IRRIGATION OF 124.5 ACRES. The right is limited to 1.56 cubic foot per second, if available at the original well; NW $\frac{1}{4}$  SW $\frac{1}{4}$ , SECTION 11, T 6 S, R 1 W, WM; 3970 FEET SOUTH AND 370 FEET EAST FROM THE NW CORNER OF SECTION 11, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2 $\frac{1}{2}$  acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

NE $\frac{1}{4}$ NW $\frac{1}{4}$	17.8 ACRES
NW $\frac{1}{4}$ NW $\frac{1}{4}$	34.2 ACRES
SW $\frac{1}{4}$ NW $\frac{1}{4}$	39.0 ACRES
SE $\frac{1}{4}$ NW $\frac{1}{4}$	18.0 ACRES
NE $\frac{1}{4}$ SW $\frac{1}{4}$	8.4 ACRES
NW $\frac{1}{4}$ SW $\frac{1}{4}$	7.1 ACRES

SECTION 11  
TOWNSHIP 6 SOUTH, RANGE 1 WEST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to add an additional point of appropriation located as follows:

NW $\frac{1}{4}$  NW $\frac{1}{4}$ , SECTION 11, T 6 S, R 1 W, WM; 120 FEET SOUTH AND 1240 FEET EAST OF THE NW CORNER OF SECTION 11.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:


1. The proposed change shall be completed on or before October 1, 1994.

2. The quantity of water diverted at the new point of appropriation (well), together with that diverted at the old point of appropriation, shall not exceed the quantity of water available from the original point of appropriation.
3. When required by the Department the water user shall install in-line flow meters or other suitable devices for measuring and recording the quantity of water used. The type and plans of the measuring devices must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
4. Water shall be acquired from the same aquifer as the original point of appropriation.
5. If substantial interference with an existing well having a water right in effect as of the effective date of this change, occurs due to withdrawal of water from the additional point of appropriation, the use of water from the additional point of appropriation may be regulated until or unless the Department approves a plan or implements an alternative administrative action to mitigate the interference.

Certificate 45199 is canceled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
