## ORDER APPROVING A TEMPORARY CHANGE IN PLACE OF USE

Pursuant to ORS 540.510 to 540.530 and 540.570, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7829 submitted by

WESTLAND IRRIGATION DISTRICT PO BOX 416 STANFIELD, OR 97875

The primary water uses to be modified are portions of Permits 7400 and 27583. The applicant, an IRRIGATION DISTRICT as defined in ORS 540.505 (1), has certified that the water has been applied to the land described in the portions of the permits to be transferred and has requested a change in place of use of the permits listed in **TABLE I.** to the location listed in **TABLE II.** 

The permits allow the use of the Umatilla River and McKay Reservoir for IRRIGATION (Permit 27583) and SUPPLEMENTAL IRRIGATION (Permit 7400) of 0.85 acre. The priority dates of the rights are 7/1/1924 for Permit 7400 and 4/12/61 for Permit 27583.

All townships and ranges are North and East of the Willamette Meridian, respectively.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the permits.

# THESE CHANGES TO EXISTING WATER RIGHTS MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The change shall be effective upon signature by the Director.
- 2. The place of use described in **TABLE I.** shall not be irrigated as a part of these water rights for the 1998 2000 irrigation seasons.
- 3. The use shall revert to the authorized place of use at the end of the 2000 irrigation season.
- 4. The approval of this temporary transfer may be revoked or modified if the Department finds the change causes injury to any existing water right.
- 5. The use of the remainder of Permits 7400 and 27583 shall be in accordance with their terms and conditions.
