Findings of Fact

- On March 30, 2018, MIKE CEREGHINO filed an application to change the point of diversion under Certificates 83023 and 83331. The Department assigned the notification number T-12884.
- Notice of the notification of the intention to change the point of diversion was published on April 10, 2018, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
- 3. The first right included in the notification is as follows:

Review Criteria (ORS 540.510(6))

- 6. The Sturgeon Lake/Dairy Creek Restoration Project of the West Multnomah Soil and Water Conservation District and other partners has created a reasonable expectation of a change in the surface level of Dairy Creek that impairs or threatens to impair access to a point of diversion authorized for Certificates 83023 and 83331.
- 7. The proposed change would not result in injury to other water rights.

Conclusions of Law

The proposed change in point of diversion due to government action in notification T-12884 is consistent with the requirements of ORS 540.510(6).

Now, therefore, it is ORDERED:

- 1. The change proposed in T-12884 is approved and effective immediately.
- 2. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 83023 and 83331 and any related decree.
- 3. Water right certificates 83023 and 83331 are cancelled. Certificates will be issued to describe the change in point of diversion for the rights included in T-12884. Together, the new Certificates shall supersede Certificates 83023 and 83331.
