O R D E R

On April 3, 1970, Philip J. and Phyllis D. Blake submitted an affidavit that they are the owners of a portion of the lands claimed to have been irrigated as described in a certificate of registration; that they have abandoned said claim of water right appurtenant to the following described lands:

Beginning at the point of intersection of the South line of the James Smart Donation Land Claim #42 Township 6 South, Range 3 West of the Willamette Meridian, Marion County, Oregon and the Center Line of Windsor Island Road, said point also being the most Southerly Southeast corner of a tract of land conveyed to Earl J. Weathers and Hazel I. Weathers as recorded in Volume 513, Page 753, Deed Records for Marion County, Oregon; thence North 89° 40' West along the South line of said Smart Donation Land Claim 2052.94 feet to a stone monument described in a tract of land conveyed to Philip J. Blake and Phyllis D. Blake as recorded in Volume 383, Page 025, Deed Records for Marion County, Oregon; thence North along the East line of said Blake tract 698.83 feet; thence South 89° 40' East and parallel to the South line of the said Smart Donation Land Claim 1665.35 feet to a point on the Center line of said Windsor Island Road; thence South 34° 09' East along the Center line of said Windsor Island Road 202.95 feet; thence South 27° 09' East along the Center line of said Windsor Island Road 599.30 feet to the point of beginning,

and request the same be canceled.


That part of the claimed right in question is for the use of not to exceed 232 gallons per minute from a well located 2300 feet South and 750 feet East from the Northwest corner of Section 34, Township 6 South, Range 3 West, W.M., with a beginning date of January 11, 1955, for irrigation of 7.6 acres in SW¼ NW¼ and 4.0 acres in

NW¼ SW¼, Section 34, Township 6 South, Range 3 West, W.M., and is described in the certificate of registration recorded in Volume 8, page 1677, Ground Water Registration Records.

That part of the claimed right for the use of not to exceed 268 gallons per minute from the described well for irrigation of 2.0 acres in SE¼ NE¼, Section 33, and 11.4 acres in SW¼ NW¼, Section 34, Township 6 South, Range 3 West, W.M., and described in said certificate, is not in question in this proceeding.

NOW, THEREFORE, it is hereby ORDERED that the claim of a water right for the use of not to exceed 232 gallons per minute from a well located 2300 feet South and 750 feet East from the Northwest corner of Section 34, Township 6 South, Range 3 West, W.M., with a beginning date of January 11, 1955, for irrigation of 7.6 acres in SW¼ NW¼ and 4.0 acres in NW¼ SW¼, Section 34, Township 6 South, Range 3 West, W.M., and described in the certificate of registration recorded in Volume 8, page 1677, Ground Water Registration Records, is canceled.
