ORS 540.621 directs the Commission to enter an order canceling a water right whenever the owner of a perfected and developed water right certifies under oath to the Commission that the water right has been abandoned and the owner desires to cancel the right.

Findings of Fact

- On August 8, 2004, the Department received an affidavit from Rick Hrdlicka, P.O. Box 958, Sisters, Oregon, stating Rick Hrdlicka is the owner of lands and the water right appurtenant as evidenced by Certificate 75878, State Record of Water Right Certificates. The affidavit further states a portion of the water right appurtenant to the property has been abandoned and requests the certificate be canceled.
- 2. Pursuant to OAR 690-017-002(a), the Department has determined that Rick Hrdlicka is the record owner, as established by county deed records, of property to which a portion of the water right evidenced by Certificate 75878 is appurtenant.
- 3. Certificate 75878 allows for the use of 13.62 cubic feet per second (cfs) of water from Squaw Creek, tributary to the Deschutes River, for irrigation of 680.8 acres and domestic use. The date of priority is November 1904.
- 4. The portion of Certificate 75878 which has been abandoned is for the use of 0.44 cfs from Squaw Creek tributary to the Deschutes River for irrigation and domestic use located as follows:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order.

Conclusions of Law

The Director of the Water Resources Department concludes that a portion of the right evidenced by Water Right Certificate 75492 has been abandoned in accordance with the provisions of ORS 540.621 and shall be canceled.

Now, therefore, it is ORDERED:

- 1. Certificate 75878 is canceled.
- 2. The Department shall issue Certificate 80952, a new and superseding certificate, to describe the remaining portion of the perfected and developed water right NOT canceled by the provisions of this order.
