ORDER APPROVING A CHANGE IN USE AND PLACE OF USE

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6696 submitted by

RICKREALL COMMUNITY WATER ASSOCIATION  
P.O. BOX 44  
RICKREALL, OREGON 97371.

The right to be modified, as evidenced by Certificate 46725, was perfected under Permit G-1911 with a date of priority of JULY 26, 1961. The right allows the use of A WELL, a tributary of the HAYDEN SLOUGH BASIN, for IRRIGATION OF 51.0 ACRES. The right is limited to 0.64 cubic foot per second, if available at the original well; NW $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected within DOVE DLC 59, SECTION 2, T 8 S, R 4 W, WM; 2130 FEET SOUTH AND 2690 FEET WEST FROM THE NE CORNER OF DOVE DLC 54, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2 $\frac{1}{2}$  acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

THESE CHANGES TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 1995. *Extended to Oct 1, 2000.*
2. The quantity of water appropriated during the irrigation season, between March 1 and October 31 of year, shall not exceed 127.5 Acre Feet. The rate of appropriation shall not exceed 0.64 cubic feet per second.
3. The water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
5. The former place of use shall no longer be irrigated as part of this water right.

Certificate 46725 is cancelled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.

The order of the Water Resources Director entered July 28, 1994, at Volume 28, Page 242, approving Transfer Application 6696 contained typographical errors. That order is rescinded and this order entered in its place.
