ORDER APPROVING A CHANGE IN POINT OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves TRANSFER 6214 submitted by

CITY OF KLAMATH FALLS P.O. BOX 237 KLAMATH FALLS, OR 97601

to use the waters of WELL 10 in the LINK RIVER BASIN for MUNICIPAL PURPOSES.

The right to be transferred, as evidenced by Certificate 32193, was perfected under Permit G-1541 with a date of priority of FEBRUARY 15, 1960. The right is limited to 1.0 cubic foot per second, if available at the original well; WELL 3 - SE 1/4 NW 1/4, SECTION 32, T 38 S, R 9 E, W.M.; 2215 FEET SOUTH AND 1160 FEET EAST FROM THE NW CORNER SECTION 32, or its equivalent in case of rotation, measured at the well.

The new point of appropriation is located as follows:

SE 1/4 NW 1/4, SECTION 32, T 38 S, R 9 E, W.M.; WELL 10 - 305 FEET NORTH AND 1388 FEET EAST FROM THE NW CORNER OF SECTION 32.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 1992.
- The quantity of water diverted at the new point of appropriation (well 10) shall not exceed the quantity of water available from the original point of appropriation (well 3).
- 3. When required by the Department the water user shall install an inline flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 4. The well at the new point of appropriation shall be constructed to the well construction standards in effect as of the date of this order and must include an access port.
- 5. Water shall be acquired from the same aquifer as the original point of appropriation.
- 6. If well 3 is to be abandoned, it shall be abandoned according to the provisions of OAR Chapetr 690, Division 220.

Certificate 32193 is hereby canceled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
