ORDER APPROVING TRANSFER NO. 4018

On August 7, 1978, an application was filed in the office of the Water Resources Director by Lyle Woodcock for approval of a change in place of use of water from Applegate River, pursuant to the provisions of ORS 540.510 to 540.530.

The certificate recorded at page 37492, Volume 29, State Record of Water Right Certificates, in the name of C. A. Trumbly, describes a right which includes the use of not to exceed 0.2 cubic foot per second from Applegate River for irrigation of a certain 1.75 acres in SE<sup>1</sup>/<sub>4</sub> NW<sup>1</sup>/<sub>4</sub>, 7.5 acres in NE<sup>1</sup>/<sub>4</sub> SW<sup>1</sup>/<sub>4</sub> and 0.75 acre in NW<sup>1</sup>/<sub>4</sub> SW<sup>1</sup>/<sub>4</sub> of Section 35, Township 37 South, Range 5 West, W.M., with a date of priority of February, 1892.

Water for the said right is diverted, through the Laurel Hill Ditch, from a point located 125 feet North and 500 feet East from the Center Corner of Section 1, being within the SW4 NE4 of Section 1, Township 38 South, Range 5 West, W.M.

The applicant herein, owner of the lands above described, proposes to change the place of use therefrom and, without loss of priority, to irrigate in lieu thereof, a certain 10.0 acres in  $SE_4^1$   $SW_4^1$  of Section 35, Township 37 South, Range 5 West, W.M.

Mr. Robert B. Steimer, Watermaster, has filed a statement to the effect that the proposed change in place of use may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in place of use may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the requested change in place of use, as described herein, without loss of priority, is approved.

It is FURTHER ORDERED that said water so transferred shall be applied to beneficial use on or before October 1, 1980.

It is FURTHER ORDERED that the certificate of water right recorded at page 37492, Volume 29, State Record of Water Right Certificates, is canceled; and in lieu thereof a new certificate be issued covering the balance of the right NOT involved in this proceeding; and upon proof satisfactory to the Water Resources Director of completion of works and beneficial use of water to the extent intended under this provisions, a confirming certificate of water right shall be issued to the applicant herein.
