ORDER APPROVING A CHANGE IN PLACE OF USE AND CHARACTER OF USE

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7359 submitted by

ROBIN HURT AND JAMES A. VANGRINSVEN 18770 FROST ROAD DALLAS, OREGON 97338.

The right to be modified, as evidenced by a portion of Certificate 47950, was perfected under Permit 37246 with a date of priority of SEPTEMBER 20, 1972. The right allows the use of AN UNNAMED STREAM, a tributary of TEAL CREEK, for IRRIGATION OF 0.4 ACRE. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.005 cubic foot per second, if available at the authorized point of diversion: LOT 2 (SW¼ SW¾), SECTION 27, T 8 S, R 6 W, WM; 100 FEET NORTH AND 340 FEET EAST FROM THE SW CORNER, SECTION 27, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under an other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

NW¼ NW¼ 0.4 ACRE SECTION 34 TOWNSHIP 8 SOUTH, RANGE 6 WEST, W.M.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described ${\sf var}$

The applicant proposes to change the character of use to DOMESTIC USE FOR ONE FAMILY. The applicant proposes to change the place of use to:

LOT 2 (SW¼ SW¼)

SECTION 27

TOWNSHIP 8 SOUTH, RANGE 6 WEST, W.M.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 1996.
- 2. The former place of use shall no longer be irrigated as a part of this water right.
- 3. The total diversion for domestic use shall not exceed 0.1 acre-foot of water.
- 4. The use of water under this right shall be limited to the irrigation season, April 1 to September 30 of each year.

Certificate 47950 is cancelled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
