On May 6, 1977, an application was filed in the office of the Water Resources Director by Ross Iverson for a change in place of use under an existing water right of record, pursuant to the provisions of ORS 540.510 to 540.530.

As modified under the provisions of the order of the Water Resources Director entered on November 13, 1975 approving transfer application No. 3100, a water right previously described by the certificate recorded at page 15111, Volume 12, State Record of Water Right Certificates, exists for the appropriation of not to exceed 0.30 cubic foot per second from Butte Creek for irrigation of a certain 24.0 acres in NE½ SE½ of Section 24, Township 5 South, Range 1 West, W.M., with a date of priority of July 3, 1940 for 0.15 cubic foot per second and a date of priority of July 22, 1940 for 0.15 cubic foot per second.

Water for the said right is diverted from two points located (1) 1100 feet South and 800 feet West and (2) 1600 feet South and 50 feet East from the North quarter corner of Section 25, being within the (1) NE<sup>1</sup>/<sub>4</sub> NW<sup>1</sup>/<sub>4</sub> and (2) SW<sup>1</sup>/<sub>4</sub> NE<sup>1</sup>/<sub>4</sub> of Section 25, Township 5 South, Range 1 West, W.M.

The applicant herein, owner of the lands above described, proposes to change the place of use therefrom and, without loss of priority, to irrigate in lieu thereof a certain 24.0 acres in SE<sup>1</sup><sub>4</sub> SW<sup>1</sup><sub>4</sub> of Section 24, Township 5 South, Range 1 West, W.M.

Mr. Keith M. Palmer, Watermaster, has filed a statement to the effect

that the proposed change in place of use may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in place of use may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the requested change in place of use as described herein, without loss of priority, is approved.

It is FURTHER ORDERED that said water so transferred shall be applied to beneficial use on or before October 1, 1979.

It is FURTHER ORDERED that upon proof satisfactory to the Water Resources

Director of completion of works and beneficial use of water to the extent intended

under the provisions of this order, a confirming certificate of water right shall

be issued to the applicant herein.
