AMENDED ORDER

On June 5, 1961, the State Engineer entered an order approving the application of C. R. Hause for a change in point of diversion of water from Eightmile Creek which provided in part as follows, to-wit:

"NOW, THEREFORE, it hereby is ORDERED that the proposed change in point of diversion of water from Eightmile Creek, to-wit:

From a point located 70 feet North and 2136 feet West from the southwest corner of Section 19, and being within the SW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 24, Township 1 South, Range 12 East, W.M.

To a point to be located 200 feet South and 530 feet East from the southwest corner of Section 19, and being within the NW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 30, Township 1 South, Range 13 East, W.M., and

To a point to be located 135 feet North and 1270 feet West from the southwest corner of Section 19, and being within the SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 24, Township 1 South, Range 12 East, W.M.,

for the irrigation of 1.21 acres in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ and 2.76 acres in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 24 and 10.68 acres in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 25, Township 1 South, Range 12 East, W.M., and 3.96 acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 19 and 6.96 acres in the NW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 30, Township 1 South, Range 13 East, W.M., with a date of priority of 1889, be and the same is hereby approved."

From a survey made April 11, 1962, by Mr. Larry W. Jebousek, Watermaster of District No. 3, it appears that the second point of diversion above described is actually located 340 feet south and 760 feet east from the southwest corner of Section 19, and being within the NW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 30, Township 1 South, Range 13 East, W.M., and the third point of diversion above described is actually located 200 feet south and 1085 feet west from the southwest corner of Section 19, and being within the NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 25, Township 1 South, Range 12 East, W.M.

Since the third point of diversion is actually located in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 25, Township 1 South, Range 12 East, W.M., instead of the SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 24, said Township and Range, the State Engineer's Order, entered June 5, 1961, should be amended to correctly describe the actual locations of the pumping plants.

NOW, THEREFORE, it hereby is ORDERED that that part of the State Engineer's Order entered June 5, 1961, above set forth be deleted therefrom and insert in lieu thereof the following, to-wit:

NOW, THEREFORE, it hereby is ORDERED that the proposed change in point of diversion of water from Eightmile Creek, to-wit:

From a point located 70 feet north and 2136 feet west from the southwest corner of Section 19, and being within the SW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 24, Township 1 South, Range 12 East, W.M.


To a point to be located 340 feet south and 760 feet east from the southwest corner of Section 19, and being within the NW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 30, Township 1 South, Range 13 East, W.M.

To a point to be located 200 feet south and 1085 feet west from the southwest corner of Section 19, and being within the NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 25, Township 1 South, Range 12 East, W.M.

for the irrigation of 1.21 acres in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ and 2.76 acres in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 24 and 10.68 acres in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 25, Township 1 South, Range 12 East, W.M., and 3.96 acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 19 and 6.96 acres in the NW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 30, Township 1 South, Range 13 East, W.M., with a date of priority of 1889, is approved.
