ORS 540.505 to 540.580 establishes the process in which a water right holder may submit a request to transfer the point of diversion, place of use, or character of use authorized under an existing water right. OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

Applicant

ROBERT MACE 8825 HIGH BANKS RD. CENTRAL POINT, OR 97502

Findings of Fact

- 1. On July 8, 2005, Robert Mace filed a transfer application to change the character of use under Permit 25859, previously modified by T-8594. On June 28, 2006, Certificate 82241 was issued confirming the changes proposed under T-8594. The Department assigned the application number T-9968.
- 2. On March 16, 2007, David Hoiland, authorized representative for Robert Mace, amended the application and map to add a change in place of use, accompanied by the required fees.
- 3. The right to be transferred is as follows:

Certificate: 82241 in the name of ROBERT MACE (perfected under Permit S-25859, as

modified by T-8294)

Use: IRRIGATION of 26.3 ACRES
Priority Date: NOVEMBER 18, 1958
Rate: 0.33 CUBIC FOOT PER SECOND

Limit/Duty: ONE-EIGHTIETH cfs per acre, not to exceed 4.5 acre-feet per acre irrigated

during the irrigation season of each year.

Source: ROGUE RIVER, tributary to PACIFIC OCEAN

- 5. Application T-9968 proposes to change the character of use to year round industrial use.
- 6. Notice of the application for transfer was published on July 19, 2005, pursuant to ORS 540.520 and OAR 690-380-4000. No comments were filed in response to the notice. However, the Oregon Department of Fish and Wildlife indicated the proposed change would not injure instream water rights.
- 7. On April 25, 2007, the Department mailed a draft of the Preliminary Determination proposing to approve Transfer Application T-9968 to the applicant. The draft Preliminary Determination set forth a deadline of May 31, 2007, for the applicant to respond. The applicant's agent requested additional time to respond, which the Department granted.
- 8. On July 10, 2007, David Hoiland, authorized representative for Robert Mace, responded to the draft Preliminary Determination by mail, requesting a change in season of use from the irrigation season to year round use, while maintaining the ability to divert water at the same rate allowed in the original right on a non-continuous basis. The applicant proposes to limit the annual volume to the maximum allowed under the original water right by using the existing in-line flow meter to monitor and record water use. Mr. Hoiland requested that the Department proceed with issuance of a Preliminary Determination and provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer.
- 9. On July 27, 2007, the Department issued a Preliminary Determination proposing to approve Transfer T-9968 and mailed a copy to the applicant. Additionally, notice of the Preliminary Determination for the transfer application was published on the Department's weekly notice on July 31, 2007, and in the Medford Mail Tribune newspaper on August 9, 16 and 23,

- 2007, pursuant to ORS 540.520 and OAR 690-380-4020. No protests were filed in response to the notice.
- 10. Water has been used within the last five years according to the terms and conditions of the right, and no evidence is available that would demonstrate that the right is subject to forfeiture under ORS 540.610.
- 11. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing right are present.
- 12. The proposed changes, including change of the season to year round, would not result in enlargement of the right, as long as the diversion rate for the new use does not exceed the authorized maximum instantaneous diversion rate on a non-continuous basis, and does not exceed the duty allowed for the original use, being 118.35 acre-feet per year.
- 13. The proposed changes would not result in injury to other water rights.

Conclusions of Law

The proposed changes in character of use and place of use in application T-9968 are consistent with the requirements of ORS 540.505 to 540.580, and OAR 690-380-5000, and will be approved provided that protests are not filed pursuant to OAR 690-380-4030.

Now, therefore, it is ORDERED:

- 1. The changes in character of use and place of use proposed in application T-9968 are approved.
- Water right Certificate 82241 is cancelled.
- 3. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificate 82241 and any related decree, with the exception that the season of use will be extended to year round.
- 4. The quantity of water diverted at the point of diversion may occur year-round at a rate not to exceed 0.33 cfs on a non-continuous basis and shall be further limited to a total volume of water diverted not to exceed 118.35 acre-feet per year.
- 5. The water user shall maintain and operate the existing measurement device for measuring and recording the quantity of water diverted, and shall make such improvements as may be required by the Department.
- 6. The approved changes shall be completed and full beneficial use of the water shall be made on or before **October 1, 2008.** A Claim of Beneficial Use prepared by a Certified Water Rights Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
