## ORDER APPROVING ADDITIONAL POINTS OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6954 submitted by

The first right to be modified, as evidenced by Certificate 53178, was perfected under Permit G-6600 with a date of priority of NOVEMBER 12, 1975. The right allows the use of WELL # 1, in the UMATILLA RIVER BASIN, for IRRIGATION 400 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.2 cubic foot per second, if available at the original well; NE% SW%, SECTION 30, T 3 N, R 30 E, WM; 30 FEET SOUTH AND 640 FEET WEST FROM THE CENTER, SECTION 30, or its equivalent in case of rotation, measured at the well.

The second right to be modified, as evidenced by Certificate 53187, was perfected under Permit G-8041 with a date of priority of February 21, 1978. The right allows the use of WELL # 1, in the UMATILLA RIVER BASIN, for SUPPLEMENTAL IRRIGATION OF 123.6 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.68 cubic foot per second, if available at the original well; NE½ SW½, SECTION 30, T 3 N, R 30 E, WM; 30 FEET SOUTH AND 640 FEET WEST FROM THE CENTER, SECTION 30, or its equivalent in case of rotation, measured at the well.

The third right to be modified, as evidenced by Certificate 53188, was perfected under Permit G-8367 with a date of priority of August 2, 1978. The right allows the use of WELL # 2, in the UMATILLA RIVER BASIN, for IRRIGATION OF 260.0 ACRES AND SUPPLEMENTAL IRRIGATION OF 276.4 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 4.38 cubic feet per second, if available at the original well; SW% SW%, SECTION 20, T 3 N, R 30 E, WM; 100 FEET NORTH AND 80 FEET EAST FROM THE SW CORNER, SECTION 20, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

SECTION 20 TOWNSHIP 3 NORTH, RANGE 30 EAST, W.M. The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to add an additional point of appropriation for certificate 53188 to:

WELL # 1 - NE% SW%, SECTION 30, T 3 N, R 30 E, WM; 30 FEET SOUTH AND 640 FEET WEST FROM THE CENTER OF SECTION 30.

The applicant proposes to add an additional point of appropriation for certificates 53178 and 53187 to:

WELL # 2 - SW% SW%, SECTION 20, T 3 N, R 30 E, WM; 100 FEET NORTH AND 80 FEET EAST FROM THE SW CORNER, SECTION 20.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

THIS CHANGE TO EXISTING WATER RIGHTS MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 1998.
- 2. The quantity of water diverted at the new point of appropriation (well), together with the quantity diverted at the old point of appropriation, shall not exceed the quantity of water lawfully available from the original point of appropriation.
- 3. The water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 4. Water shall be acquired from the same aquifer as the original point of appropriation.

Certificates 53178, 53187 and 53188 are cancelled. When satisfactory proof of the completed change is received, new certificates confirming these water rights will be issued.
