OF L. G. ROSS FOR THE APPROVAL OF) O R D E R
A CHANGE IN THE USE OF WATER.)

Now at this time this matter coming on for consideration by the State Engineer on the application of L. G. Ross of Beaver, Oregon, the facts appearing as follows:

On December 16, 1914, there was issued by the State Water Board of Oregon, a certificate of water right No. 740 in the name of H. S. Davidson for the use of 0.22 second foot of water from Poland Creek for the irrigation of 17.5 acres of land as follows: 0.5 acre in SW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 28; 3 acres in SW $\frac{1}{4}$ SE $\frac{1}{4}$, 3 acres in SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 29; 6 acres in NW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 33, T. 3 S. R. 9 W., the date of priority of said water right being April 12, 1910. Said certificate was recorded in the record of Water Right Certificates of Tillamook County, Volume 1, page 7.

On the 27th day of July, 1917, there was issued by the State Water Board of Oregon, water right certificate No. 1787 in the name of the Beaver Improvement and Power Company for the use of 3 second feet of water from Poland Creek for domestic and power purposes on the SW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 28, T. 3 S. R. 9 W., the date of priority of said right being May 19, 1913. Said certificate was recorded in the record of Water Right Certificates of Tillamook County, Volume 1, page 33.


The water rights above described were assigned with certain reservations to the Beaver Improvement & Power Company on the 17th day of March, 1915, and passed by mesne conveyances to the petitioner herein.

The petitioner herein now proposes to use a portion of the water covered by said water rights as above described for the irrigation of 50 acres of land owned by him as follows: 6 acres in the NE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 29; 30 acres in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 29, 2 acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 28, 2.5 acres in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 32, 9.5 acres in the NW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 33, T. 3 S. R. 9 W. W. M.

Notice of the filing of said application has been given by the State Engineer by publication as provided by Chapter 219, General Laws of Oregon for 1927, and no objections have been filed to the granting of the application.

It further appearing that the proposed change may be effected without injury to other rights, it is ORDERED that same be, and it is hereby, approved, and the 0.22 second foot of water covered by Certificate No. 740, and 0.41 second foot of the quantity covered by Certificate No. 1787, may be used for the irrigation of the 50 acres of land above described, the right therefor to become appurtenant to said lands.
