#### **Findings of Fact**

- 1. On October 18, 2021, the Department issued an order approving Transfer Application T-13462, involving Certificate 95056. The order was recorded at Special Order Volume 121, Page 841.
- 2. Finding of Fact 20 contained language that referred to the document as a revised Preliminary Determination, and should be removed:

On July 16, 2021, the Department received correspondence from the applicant's agent identifying a scrivener's error in the Preliminary Determination. Under the section Determination and Proposed Action, condition #2 and #3 identified original certificate 94802, which is already cancelled, and should be replaced by superseding Certificate 95056. This revised Preliminary Determination is issued to correctly identify Certificate 95056.

3. Finding of Fact 20 is corrected to read as follows:

On July 16, 2021, the Department received correspondence from the applicant's agent identifying a scrivener's error in the Preliminary Determination. Under the section Determination and Proposed Action, condition #2 and #3 identified original certificate 94802, which is already cancelled, and should be replaced by superseding Certificate 95056.

4. The Final Order also did not include the appeals language in the footer of the document. The Final Order is hereby corrected to include the following:

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for

reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

## Now, therefore, it is ORDERED:

- 1. The order approving T-13462, as recorded in Special Order Volume 121, Page 841, is corrected to include the Final Order appeals language.
- 2. All other provisions of Special Order Volume 121, Page 841 remain in effect.
