ORDER APPROVING A CHANGE IN PLACE OF USE

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6522 submitted by

STEVEN LYNN STONEBREAKER
63235 HALLEY ROAD
LAGRANDE, OREGON 97850.

The right to be modified was confirmed by decree of the Circuit Court of the State of Oregon for UNION County as evidenced by a PORTION of Certificate 6499. The decree is recorded in the Order Record of the Water Resources Director in Volume 8, at Page 1. The date of priority is 1872.

The right allows the use of GRANDE RONDE RIVER, a tributary of SNAKE RIVER, for IRRIGATION 46 ACRES. This right is limited to THREE ACRE- FEET PER ACRE IN ANY IRRIGATION SEASON, DIVERTED AT A RATE OF NOT TO EXCEED ONE-FORTIETH OF A CUBIC FOOT PER SECOND PER ACRE, if available at the authorized point of diversion: ORODELL DITCH, SW $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 31, T 2 S, R 38 E, W.M., or its equivalent in case of rotation, measured at the point of diversion from the source.

The authorized place of use is located as follows:

NW $\frac{1}{4}$ SW $\frac{1}{4}$ 21.0 ACRES
NE $\frac{1}{4}$ SW $\frac{1}{4}$ 25.0 ACRES

SECTION 23

TOWNSHIP 2 SOUTH, RANGE 38 EAST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.

The applicant proposes to change the place of use to:

NE $\frac{1}{4}$ SE $\frac{1}{4}$ 21.0 ACRES
NW $\frac{1}{4}$ SE $\frac{1}{4}$ 16.0 ACRES
NE $\frac{1}{4}$ SW $\frac{1}{4}$ 9.0 ACRES

SECTION 23

TOWNSHIP 2 SOUTH, RANGE 38 EAST, W.M.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 1993.
2. The former place of use shall no longer be irrigated as a part of this water right.

Certificate 6499 is cancelled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
