ORDER

APPROVING APPLICATION

On May 2, 1955 Cleo K. Stewart of Route 1, Box 28, Colton, Oregon filed an application for the approval of a change in place of use of water from Canyon Creek pursuant to the provisions of ORS 510.510 to 510.530.

Certificate of Water Right recorded at page 20680, Volume 15, State Record of Water Right Certificates, was issued to the Colton Irrigation Association confirming a right under Fermit No. 10842 for the use of water of Canyon Creek for the irrigation of, among other lands, 20 acres in Lot 1 (NE4 NE4), 34.9 acres in the SE4 NE4 and 14.5 acres in the SE4 SE4, Section 4, Township 5 South, Range 3 East, W. M., with a date of priority of January 30, 1933.

Cleo K. Stewart proposes to transfer the water right appurtenant to 10 acres of the land above described, to-wit:

- 5 acres in Lot A of Carlsborg Tract 1 (NET NET)
- 3 acres in Carlsborg Tract 4 (SE1 NE2)
- 2 acres in Carlsborg Tract 16 (SE2 SE2)

therefrom without loss of priority to 10 acres in the NW2 5W2, Section h,
Township 5 South, Range 3 East, W. M., said 10 acres being owned by Cleo K.
Stewart.

School District No. 53, Victor Backman and Mrs. Robert R. Burns,
owners of the lands from which the water is being transferred and the Colton
Irrigation Association through whose system the water is distributed, have
submitted written approval of the proposed change in place of use of water.

PARTS A. STANIAS Provincias Gardenas Notice by publication as provided by ORS 540.520 was not given in connection with this application for the reason said section provides notice is not required on applications for a change in place of use of water only.

No objections having been filed and it appearing that the proposed change in place of use of water from Canyon Creek may be made without injury to existing rights, the application should be approved.

" NOW, THEREFORE, it hereby is ORDERED that the proposed change in place of use of water from Canyon Creek be and the same hereby is approved and that the water right hereinbefore described as appurtenant to

- 5 scres in Lot A of Carlsborg Tract 1 (NET NET)
- 3 acres in Carlsborg Tract 4 (SE2 NE4)
- 2 acres in Carlsborg Tract 16 (SET SET)

with a date of priority of January 30, 1933, be severed therefrom and simultaneously and without loss of priority transferred to 10 acres in the NW1 SW1, Section 4, Township 5 South, Range 3 East, W. M., owned by Cleo K. Stewart.

It is FURTHER ORDERED that said water so transferred shall be applied to beneficial use on or before October 1, 1956 or within such extension of time as may be granted by the State Engineer for good cause shown.

It is FURTHER ORDERED that upon receipt of proof satisfactory to the State Engineer of complete application of water to beneficial use upon the land to which the water is transferred hereby, certificate of water right shall be issued to the Colton Irrigation Association and that the certificate of water right heretofore issued to the Colton Irrigation Association and recorded at page 20680, Volume 15, State Record of Water Right Certificates, be cancelled.
