Authority

ORS 537.705 and 540.505 to 540.580 establish the process in which a water right holder may submit a request to transfer the point of appropriation, place of use, or character of use authorized under an existing water right. OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

Applicants

Findings of Fact

Background

- 1. On August 28, 2000, Lloyd L: and Rebecca Miles filed a transfer application to change the points of appropriation and place of use under Certificates 31236, 41096, 47919, 72463, 72464, 72465, 72467, 72468 and 74297. The Department assigned the application number T-8588.
- 2. The applicants were notified by the Department on July 6, 2006, that the proposed place of use changes would result in the layering of portions of primary irrigation rights (Certificates 72468 and 41096) on top of another primary irrigation right (Certificate 76090).
- 3. On March 8, 2007, the owners of the land to which Certificate 76090 is appurtenant, being Gene and Loraine Porter, submitted a signed statement consenting to the inclusion of a portion of Certificate 76090 in Transfer T-8588 to resolve the layering issue described in Finding #2.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

- 4. On April 25, 2007, the applicant submitted a revised map, identifying 40.0 acres in the SW 1/4 of the NE 1/4 of Sec. 2, T. 27 South, R. 15 East, W.M., under Certificate 76090 to be included in the transfer, in order to resolve the layering issue described in Finding #2. The transfer application was not amended to include Certificate 76090 at that time.
- The Department mailed a copy of the draft Preliminary Determination to the applicants on April 26, 2007. The draft Preliminary Determination proposed to approve Transfer Application T-8588, provided that the applicants amended the transfer application to reflect the inclusion of Certificate 76090. Additionally, because Certificate 76090 allows only 36.88 acres in the SW ¼ of the NE ¼ of Sec. 2, T. 27 South, R. 15 East, W.M., the applicants were notified that the 40.0 acres shown on the April 25, 2007 revised map needed to be adjusted down to 36.88 acres, as described in the water right certificate. The draft Preliminary Determination set forth a deadline for the applicants to respond and submit the revised application and map.
- 6. On May 24, 2007, the Department received a revised map from the applicant's Certified Water Right Examiner showing the 36.88 acres under Certificate 76090 (SW 1/4 of the NE 1/4 of Sec. 2, T. 27 South, R. 15 East, W.M.) to be transferred.
- 7. On July 1, 2007, the applicants provided their authorization to revise the transfer and submitted an amended transfer application to include transfer of the 36.88 acres under Certificate 76090 in the transfer application.

37. Notice of the application for transfer was published on September 5, 2000, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.

- 38. On August 17, 2007, the Department issued a Preliminary Determination proposing to approve Transfer T-8588 and mailed a copy to the applicants. Additionally, notice of the Preliminary Determination for the transfer application was published on the Department's weekly notice on August 21, 2007, pursuant to ORS 540.520 and OAR 690-380-4020. No protests were filed in response to the notice.
- 39. Newspaper notice was published pursuant to 690-015-0080(1). Publication occurred in the Lake County Examiner (a newspaper having a general circulation in the area in which the change is proposed) on September 20, 27 and October 4, 2001. In accordance with OAR 690-380-0090(5), therefore, newspaper notice of the preliminary determination is not required.

Transfer Review Criteria (OAR 690-380-4010)

- 40. Water has been used within the last five years according to the terms and conditions of the rights, and there is no information in the record that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 41. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing right were present within the five-year period prior to submittal of Application T-8588.
- 42. The proposed changes would not result in enlargement of the rights.
- 43. The proposed changes would not result in injury to other water rights.

Conclusions of Law

The changes in points of appropriation and place of use proposed in application T-8588 are consistent with the requirements of ORS 537.705 and 540.505 to 540.580 and OAR 690-380-5000.

Now, therefore, it is ORDERED:

- 1. The changes in points of appropriation and place of use proposed in application T-8588 are approved.
- 2. Water right certificates 31236, 41096, 47919, 72463, 72464, 72465, 72467, 72468, 74297, and 76090 are cancelled. A new certificate will be issued describing that portion of Certificate 76090 not affected by this transfer.
- 3. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 31236, 41096, 47919, 72463, 72464, 72465, 72467, 72468, 74297, and 76090 and any related decree.
- 4. Water shall be acquired from the same aquifer (water source) as the original points of appropriation.

- 5. The quantity of water diverted at the new points of appropriation shall not exceed the quantity of water lawfully available at the original points of appropriation.
- 6. The former place of use of the transferred rights shall no longer receive water under the rights.
- 7. Prior to diverting water, the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department. The water user shall maintain and operate the measuring device as required by the Department.
- 8. The approved changes shall be completed and full beneficial use of the water shall be made on or before **October 1, 2008**. A Claim of Beneficial Use prepared by a Certified Water Rights Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
- 9. When satisfactory proof of the completed changes is received, new certificates confirming the rights transferred will be issued.
