## FINAL ORDER

Pursuant to ORS 541.329, (District Water Rights Mapping Provision), a co-petition with Powder Valley Water Control District requesting approval and acceptance of the petitioner's map showing the present location and use of water rights within the petitioned area was submitted to the Oregon Water Resources Department on June 17, 1993, by the co-petitioner:

The Water Right Certificates petitioned are all of the Rights of Record evidenced by Water Right Certificates, hereinafter called Rights of Record, numbered 2216 and 63767 of the State Record of Water Right Certificates. Certificate 63767 is modified by Special Order Volume 50, Page 707. The Rights of Record allow use of the waters North Powder River and Big Muddy Creek, tributaries of Powder River, tributaries to the Snake River for the irrigation of **88.0** acres.

The rights to be modified as a result of the petition and requested cancellations are listed in **TABLE 1**.

from Northwest Corner Section 20, Township 7 South,

Range 39 East, W.M.

The Director has examined the petition and map of Tommy Duncan and the Report of Findings prepared by Department staff. Based on the examination and report, the Director has determined that Tommy Duncan has met the requirements of ORS 541.325 to 541.333.

NOW THEREFORE, it is hereby ORDERED:

- That Tommy Duncan's petition and map are accepted and approved.
- That Rights of Record numbered 2216 and 63767, as modified by Special Order Volume 50, Page 707, of the State Record of Water Right Certificates are canceled.
- That confirming certificates of water right conforming to the approved petition, for the irrigation of **88.00** acres.
- That there are no cancellations pursuant to ORS 540.621.
- ► That there are no remaining right certificates to be issued.
