On April 19, 1983, an application was filed in the office of the Water Resources Director by Arthur B. Page for approval of a change in place of use of water from North Santiam River, pursuant to the provisions of ORS 540.510 to 540.530.

By supplemental Decree of the Circuit Court for Marion County, Oregon, entered November 22, 1961, In the Matter of the Determination of the Relative Rights to the Use of the Waters of North Santiam River and Its Tributaries, a water right was allowed in the name of Sidney Irrigation Cooperative for the use of the waters of North Santiam River for irrigation of, among other lands, a certain 7.0 acres in NE 1/4 SW 1/4, 0.4 acre in SE 1/4 SW 1/4, 10.1 acres in NE 1/4 SE 1/4, 26.6 acres in NW 1/4 SE 1/4, 12.6 acres in SW 1/4 SE 1/4, 8.3 acres in SE 1/4 SE 1/4, Section 2, Township 10 South, Range 3 West, WM, in James M. Bates DLC 65, being tabulated in the name of Charley Hart in Volume 16, page 8, with a date of priority of 1870 as evidenced by certificate of water right recorded at page 29924, Volume 21, State Record of Water Right Certificates.

The applicant herein, owner of the lands described above, proposes to transfer the water right therefrom, without loss of priority, to a certain 22.7 acres in NW 1/4 NW 1/4, 29.4 acres in SW 1/4 NW 1/4 and 12.9 acres in NW 1/4 SW 1/4, Section 30 Township 9 South, Range 2 West, WM.

Clifton R. King, Watermaster, has filed a statement to the effect that the proposed change in place of use may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in place of use may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the requested change in place of use, as described herein, without loss of priority, is approved.

It is FURTHER ORDERED that said water so transferred shall be applied to beneficial use on or before October 1, 1984.

It is FURTHER ORDERED that upon proof satisfactory to the Water Resources Director of complete application of water to beneficial use on the lands to which the water is transferred hereby, a certificate of water right shall be issued to Sidney Irrigation Cooperative confirming this and other changes within the District.
