Findings of Fact

1. The Department issued an order approving Transfer Application T-12348 on December 28, 2016. The order was recorded at Special Order Volume 103, Page 645.
2. Following the issuance of Special Order Volume 103, Page 645, scrivener's errors were discovered in the place of use table for the proposed lands.
3. On August 28, 2017, as evidenced by Special Order Volume 105, Page 675 to correct the errors in the place of use table for the proposed lands.
4. Following the issuance of Special Order Volume 105, Page 675, it was discovered that the errors had not been corrected to the satisfaction of the Department. This Order is issued to correct the errors in the proposed place of use table and identified in the table below (Finding of Fact #5) in ***bold and italic***.
5. Transfer Application T-12348 proposes to add the additional point of appropriation to all of the acres and change the place of use for a portion of the primary irrigation acres. The proposed changes are outlined in the tables below as follows:


