Findings of Fact

1. On November 9, 2020, the Department issued an order approving Transfer T-13467. The order was recorded at Special Order Volume 118, Pages 37-42.
2. The order contained scrivener errors in Finding of Facts 7 and 8 incorrectly identifying the application number as T-13236 and the incorrect proposed place of use in Finding of Fact 7.

3. The correct temporary transfer application number is T-13467, and the correct proposed place of use is as follows.


