This order confirms the right of record to use the waters of ROGUE RIVER, tributary to PACIFIC OCEAN, for IRRIGATION OF 1.69 ACRES.

This right was perfected under Permits S-8853 and S-50957. The date of priority for Permit S-8853 is SEPTEMBER 29, 1916 and the date of priority for Permit S-50957 is AUGUST 21, 1987.

The amount of water to which this portion of the right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.021 CUBIC FOOT PER SECOND (CFS) WITH PRIORITY DATE OF SEPTEMBER 29, 1916 AND 0.12 CFS WITH PRIORITY DATE OF AUGUST 21, 1987, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of 1/52 of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 6.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the new point of diversion, together with that diverted at the old points of diversion, shall not exceed the quantity of water lawfully available from the original points of diversion.

The water user shall maintain a fish screen or fish by-pass device, as appropriate, at the point of diversion.


The water user shall cooperate with the Grants Pass Irrigation District as necessary to ensure compliance with water use measurement and annual reporting requirements under ORS 537.099.

This order is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered MAY 11, 2005, at Special Order Volume 64, Page 381, approving Transfer Application 9357, modifies a portion of Certificate 80971, State record of Water Right Certificates.

This right is subject to all other conditions and limitations contained in Certificate 80971 and any related decrees.

The Department will issue a superseding certificate describing the right when it determines that it is necessary for record keeping or when the district or users within the district request issuance of a new certificate.
