ORDER APPROVING A CHANGE IN PLACE OF USE, SWITCH IN PRIORITY DATES

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6547 submitted by

TOM "MAC" KERNS ROUTE 1 BOX 10 HAINES, OREGON 97814.

The right to be modified was confirmed by decree of the Circuit Court of the State of Oregon for BAKER County as evidenced by a PORTION of Certificate 4253. The decree is recorded in the Order Record of the Water Resources Director in Volume 6, at Page 291. The dates of priority are 1864 FOR 40 ACRES; 1872 FOR 20 ACRES; 1892 FOR 40 ACRES; 1900 FOR 20 ACRES; AND 1909 FOR 40 ACRES.

The right allows the use of PINE CREEK, a tributary of the POWDER RIVER, for IRRIGATION OF 160.0 ACRES. This right is limited to 1/40th OF ONE CUBIC FOOT PER SECOND PER ACRE, if available at the authorized point of diversion: L.B. AND O.P. ISON DITCH, or its equivalent in case of rotation, measured at the point of diversion from the source.

The authorized place of use is located as follows:
