ORDER APPROVING CHANGES IN POINTS OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves TRANSFER 6534 submitted by

MARGARETE LANDSEM
7661 SOUTH OSTER ROAD
WOODBURN, OREGON 97071

to use the waters of WELLS 3, 4, AND 5 in the BUTTE CREEK BASIN for IRRIGATING 32.0 ACRES UNDER PERMIT G-10294 AND IRRIGATING 105.5 ACRES UNDER PERMIT G-10475.

The first right to be transferred, as evidenced by Certificate 62692, was perfected under Permit G-10294 with a date of priority of NOVEMBER 15, 1983. The right is limited to 0.40 cubic foot per second, if available at the original wells 1 and 2, or its equivalent in case of rotation, measured at the well.

The other right to be transferred, as evidenced by A PORTION of Certificate 65628, was perfected under Permit G-10475 with a date of priority of JANUARY 30, 1985, FOR 0.51 CFS AND JANUARY 31, 1985, FOR 0.34 CFS. The right is limited to 0.85 cubic foot per second, if available at the original wells 1 and 2, or its equivalent in case of rotation, measured at the well.

The new points of appropriation are located as follows:

NW 1/4 SW 1/4, SECTION 20; SE 1/4 SE 1/4, SECTION 19; NW 1/4 NE 1/4, SECTION 30; T 5 S, R 1 E, W.M.; WELL 3 - 480 FEET SOUTH AND 2610 FEET WEST FROM CENTER OF SECTION 20; WELL 4 - 870 FEET NORTH AND 60 FEET WEST FROM SE CORNER SECTION 19; WELL 5 - 30 FEET SOUTH AND 1460 FEET WEST FROM NE CORNER SECTION 30.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2 1/2 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.


The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 1993.
2. The quantity of water diverted at the new points of appropriation (well) shall not exceed the quantity of water available from the original points of appropriation.
3. When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
4. Water shall be acquired from the same aquifer as the original points of appropriation.

Certificate 62692 and 65628 are cancelled. A new certificate will be issued to confirm that portion of certificate 65628 NOT involved in this transfer. When satisfactory proof of the completed change is received, new certificates confirming these water rights will be issued.
