Subject: Transfer T-8643, Involving Certificates 80785, 80786, 72279, 72281, and 72283

Dear Mr. and Mrs. Durette:

We have reviewed the final proof survey relating to T-8643 and determined that "proof to the satisfaction" of the Director has been found for all of the water rights involved in this transfer. This means that you have completed the necessary changes required under Special Order Volume 59, Pages 178 - 183. As such, I am enclosing copies of two new certificates, numbered 80785 and 80786, which are issued in your names.

The certificates confirming the other changes involved in T-8643 will be issued at a later date. These certificates will be issued in the name of North Unit Irrigation District, will cover thousands of acres, and will confirm numerous changes. This is described in the special order approving the transfer:

"When the Director determines that it is necessary, or to facilitate records keeping, new certificates will be issued to confirm all completed changes for which satisfactory proof has been made and to confirm that portion of the right not modified by this or any other order." (Special Order Volume 59, Page 182)
