Findings of Fact

- 1. Eugene W. Gramzow filed an application to transfer the place of use under Certificate 74032 The Department assigned the application number T-9676.
- 2. The portion of the right to be transferred is as follows:

- 4. Water has been used within the last five years according to the terms and conditions of the right and no evidence is available that would demonstrate that the right is subject to forfeiture under ORS 540.610.
- 5. A diversion structure and ditch sufficient to use the full amount of water allowed under the existing right are present.
- 6. The proposed change would not result in enlargement of the right.
- 7. The proposed change would not result in injury to other water rights.

Conclusions of Law

The proposed changes in place of use in application T-9676 are consistent with the requirements of ORS 537.705 and 540.505 to 540.580 and OAR 690-380-5000.

Now, therefore, it is ORDERED:

- 1. The change place of use proposed in application T-9676 is approved.
- 2. Water right certificate 74032 is cancelled. A new certificate will be issued describing that portion of the right not involved in this transfer
- 3. The right to the use of the water is restricted to beneficial use at the place of use described and is subject to all other conditions and limitations contained in Certificate 74032 and any related decree.
- 4. The proposed change shall be completed on or before October 1, 2006.
- 5. A Claim of Beneficial Use prepared by a Certified Water Rights Examiner shall be submitted by the applicant to the Department by October 1, 2007.
- 6. The former place of use shall no longer be irrigated as part of this water right.
- 7. Prior to diverting water, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 8. When satisfactory proof of the completed changes is received, new certificates confirming the rights transferred will be issued.
