ORDER APPROVING ADDITIONAL POINTS OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6381 submitted by

KRAEMER FARMS
13318 DOMINIC ROAD NE
MT. ANGEL, OREGON 97362.

The right to be modified, as evidenced by Certificate 52662, was perfected under Permit G-7125 with a date of priority of JANUARY 16, 1976. The right allows the use of the ELMER ESCH WELL, a tributary of the ZOLLNER CREEK BASIN, for IRRIGATION OF 191.8 ACRES. The right is limited to 1.70 cubic foot per second, if available at the original well; NE½ NE½, SECTION 4, T 6 S, R 1 W, WM; 50 FEET SOUTH AND 340 FEET WEST FROM THE NE CORNER, SECTION 4, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and $2\frac{1}{2}$ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

TOWNSHIP 5 SOUTH, RANGE 1 WEST, W.M.

NW¼ NW¼ 37.6 ACRES SW¼ NW¼ 27.5 ACRES SECTION 3

NE¼ NE¼ 34.5 ACRES SE¼ NE¼ 30.0 ACRES

SECTION 4

TOWNSHIP 6 SOUTH, RANGE 1 WEST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to add the following points of appropriation:

SW\(\frac{1}{2}\) NW\(\frac{1}{2}\), NE\(\frac{1}{2}\), NW\(\frac{1}{2}\), NW\(\frac{1}{2}\), SW\(\frac{1}{2}\) NW\(\frac{1}{2}\), SECTION 3; T
6 S, R 1 W, WM; RODY WELL - 1990 FEET SOUTH AND 90 FEET EAST FROM THE NW CORNER, SECTION 2; KRAEMER WELL - 460 FEET SOUTH AND 940 FEET WEST FROM THE NE CORNER, SECTION 3; KRAEMER #2 WELL - 1200 FEET SOUTH AND 550 FEET EAST FROM THE N% CORNER, SECTION 3; NORB WELL - 1730 FEET SOUTH AND 270 FEET EAST FROM THE NW CORNER, SECTION 3.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- The proposed change shall be completed on or before October 1, 1996.
- The quantity of water diverted at the new points of appropriation 2. (well), together with the quantity of water diverted at the old point of appropriation, shall not exceed the quantity of water available from the original point of appropriation.
- 3. When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 4. Water shall be acquired from the same aquifer as the original point of appropriation.

Certificate 52662 is cancelled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
