FINAL ORDER

Pursuant to ORS 541.329 (District Water Rights Mapping Provision), a petition requesting approval and acceptance of district maps showing the location and use of all water rights within the boundaries of and serviced by Westland Irrigation District, was submitted to the Oregon Water Resources Commission on June 29, 1993 by the petitioner:

The Water Right Certificates, Decrees, and Transfers to be modified are portions of, or all of, the Rights of Record evidenced by the Water Right Certificates, and Decrees hereinafter called Rights of Record, including: Umatilla River Decree Volume 3 Page 229, in the name of Will Moore; Volume 15 Page 429, in the name of J. F. Murray; Volume 15 Page 425, in the name of Andrews Bros; Volume 15 Page 441, in the name of Lester Murray; Volume 3 Page 246-248 in the name of Western Land and Irrigation Company; Volume 15 Page 437-441, and Volume 16 Page 459-460 in the name of Westland Irrigation District. Also being petitioned as primary irrigation and stock uses are the transfers identified in Table V, and Certificates 2691, 41252, 51294, 53736, 55003, 64731, 64732, and 76180 of the State Record of Water Rights.

Rights of Record that are petitioned as supplemental rights include Certificates: 2670, 2682, 2691, 2688, 2689, 31292, 38873, 41252, 41941, 44896, 44897, 51357, 53736, 55003, and 76180. Diminutions of rights in their original locations were requested of Certificates 2847, 34388, 34586, 36919, 38289, 39464, 42861, 54976, and 58968. Partial cancellation of Certificates 34586, 53659, and 64698 were also requested. Domestic use, defined as in-house use, is being canceled from the decreed rights listed above having priority dates of 1900; January 9, 1900; March 14, 1903; and July 1907. The pertinent affidavits are included with Table III of the Proposed Order. The said Rights of Record allow the use of the waters of Umatilla River, its tributaries, and groundwater, all tributaries of the Columbia River, for irrigation, supplemental irrigation, domestic, and stock.

Table I lists the specific portions of the above rights to be modified by this petition.

NOTICE OF RIGHT TO JUDICIAL REVIEW

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

This statement of judicial review rights is required by ORS 536.075; it does not alter or add to existing rights or create rights that are not otherwise provided by law.

The Petitioner seeks certificates confirming the present place of use as listed in Table II for irrigation, supplemental irrigation and stock use.

The portion of the above rights to be canceled, by signed affidavits are listed in Table III.

The portions of the above rights to be diminished in their original locations, and the signed affidavits are listed in Table IV.

Transfers to be confirmed are listed in Table V.

The authorized points of diversion are listed in Table VI.

FINDINGS

The Director has examined the petition and maps submitted by Westland Irrigation District and a report prepared by Department Staff. The report is on file at the Water Resources Department. Based on the examination and report, the Director finds:

1. Westland Irrigation District is a district eligible to petition as defined by ORS 541.325(1).
2. The district filed its petition and map in a timely manner.
3. The district certified that they met the notice requirements of ORS 541.329 (4).
4. The content and quality of the district's petition and map meet the requirements of ORS 541.329.
5. The acreage petitioned is within the limits of the eligible rights and the limits set in ORS 541.331 (4).
6. Westland Irrigation District may make the proposed changes without injury to existing rights.
7. The district paid the fees required under 536.050 1(o).
8. The district is petitioning the use of water for irrigation, supplemental irrigation and stock use only. The original season, rate and duty limitations associated with the rights petitioned shall remain in effect.
9. Several users have authorized partial cancellation of water right certificates 34586, 53659, and 64698, the locations of the proposed cancellations are identified in Table III. The district has authorized cancellation of domestic use, as defined as in-house use, from the decreed rights having priority dates of 1900; January 9, 1900; March 14, 1903; and July 1907.
10. Several users have authorized partial diminishment of their water rights from primary to supplemental irrigation, the diminishments are identified in Table IV.
11. The District has requested all lands with primary irrigation rights within the current boundaries receive the supplemental permit 7400, in the name of the U.S. Bureau of Reclamation.
12. There no unresolved protests or comments.

Therefore, the Director finds that WESTLAND IRRIGATION DISTRICT has met the requirements of ORS 541.325 to 541.331.

ORDER

NOW, THEREFORE, it is hereby ORDERED that the petition and maps of water rights be accepted and approved and that the Rights of Record, Umatilla River Decree Volume 3 Page 229, in the name of Will Moore; Volume 15 Page 429, in the name of J. F. Murray; Volume 15 Page 425, in the name of Andrews Bros; Volume 15 Page 441, in the name of Lester Murray; Volume 3 Pages 246-248 in the name of Western Land and Irrigation Company; Volume 15 Pages 437-441, and Volume 16 Pages 459-460 in the name of Westland Irrigation District; and Certificates 51294, 2670, 2682, 2688, 2689, 2691, 2847, 31292, 34388, 34586, 36919, 38289, 38873, 39464, 41252, 41941, 42861, 44896, 44897, 51357, 53659, 53736, 54976, 55003, 58968, 64698, 64731, 64732, and 76180 of the State Record of Water Right Certificates be canceled.

It is FURTHER ORDERED that confirming right certificates conforming to the approved petition for primary irrigation of 7367.65 acres, supplemental irrigation of 1410.3 acres, and stock use as listed in Table II shall be issued. Transfers in Table V are confirmed.

It is FURTHER ORDERED that the 34.5 acres of water rights in Table III be canceled, and the domestic use, defined as in-house use, be canceled from the decreed rights listed above having priority dates of 1900; January 9, 1900; March 14, 1903; and July 1907.

It is FURTHER ORDERED that new certificates shall be issued for the 238.7 acres in Table IV, diminished by affidavits.

It is FURTHER ORDERED that remaining right certificates for those portions of the affected rights not altered shall be issued.

It is FURTHER ORDERED that the original season, rate, and duty limitations associated with the rights listed in Table I remain in effect.


