AMENDING ORDER

On December 18, 1934, the State Engineer entered an order approving an application of Maida Rossiter Bailey for a change in point of diversion of water from Squaw Creek, wherein the point of diversion was changed to a point to be located 1440 feet south and 660 feet west from the northeast corner of Section 17, Township 15 South, Range 10 East, W. M., for the irrigation of 16 acres in the NW4 NE4, 21 acres in the NE4 NW2, 13 acres in the SW2 NW4 and 37.5 acres in the SE2 NW4, Section 8, Township 15 South, Range 10 East, W. M., with a date of priority of 1886, and 37 acres in the NE4 SW2, 7.5 acres in the NW4 SW4, 7.5 acres in the SW4 SW4 and 35 acres in the SE4 SW2, said Section 8, with a date of priority of 1885. The ditch to which the point of diversion is being changed is the Bailey-Wilt ditch.

From a survey made by Mr. Aubrey E. Perry, Watermaster, Bend, Oregon, in connection with an application for the approval of a change in point of diversion of water involving the same ditch, it appears that the point of diversion of the Bailey-Wilt ditch is actually located 600 feet south and 1170 feet west from the east quarter corner of Section 17, and being within the NE4 SE4, said Section 17, Township 15 South, Range 10 East, W. M., and that the order of the State Engineer entered December 18, 1934 should be amended accordingly.

NCW, THEREFORE, it hereby is CRDERED that the order of the State Engineer entered December 18, 1934, approving the application of Maida Rossiter Pailey for a change in point of diversion of water from Squaw Creek is amended to describe the new point of diversion as being located 600 feet

south and 1170 feet west from the east quarter corner of Section 17, and being within the NE_{4}^{\perp} SE_{4}^{\perp} , said Section 17, Township 15 South, Range 10 East, W. M.
