ORDER APPROVING A CHANGE IN PLACE OF USE

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves TRANSFER 6423 submitted by

JAMES G. MURRAY
P.O. BOX 279
DAYS CREEK, OREGON 97429

to use the waters of DAYS CREEK, a tributary of the SOUTH UMPQUA RIVER, for the purpose of IRRIGATING 12.0 ACRES.

The right to be transferred, as evidenced by certificate 15720, was perfected under Permit 11499 with a date of priority of DECEMBER 5, 1934. This right is limited to 0.15 cubic foot per second, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 6 (SW 1/4 SE 1/4), SECTION 2, T 30 S, R 4 W, W.M.; 77 FEET NORTH AND 390 FEET EAST FROM THE SOUTH 1/4 CORNER OF SECTION 2.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the new place of use is as follows:

SW 1/4 SE 1/4 12.0 ACRES
AS PROJECTED WITHIN DLC 50
SECTION 2
TOWNSHIP 30 SOUTH, RANGE 4 WEST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

James G. and Charlotte T. Murray have affirmed that they are the owners of certain land and the water right appurtenant to it; which is for the use of 0.06 cfs for irrigation of 4.4 acres within the SE 1/4 SE 1/4 as described by certificate 15720; that they have abandoned this portion of said water right and request it be cancelled.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:


1. The proposed change shall be completed on or before October 1, 1991.
2. When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
3. The following former place of use shall no longer be irrigated as a part of this water right:

SW 1/4 SW 1/4 9.1 ACRES
AS PROJECTED WITHIN DLC 50
SECTION 1

SE 1/4 SE 1/4 7.3 ACRES
AS PROJECTED WITH DLC 50
SECTION 2
TOWNSHIP 30 SOUTH, RANGE 4 WEST, W.M.

Certificate 15720 is cancelled. The water right for the irrigation of 4.4 acres is also cancelled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
