O R D E R

On April 1, 1970, Walter H. and Altha M. Brown submitted an affidavit that they are the owners of lands claimed to have been irrigated as described in a certificate of registration; that they have abandoned said claim of water right and request the same be canceled.

That part of the claimed right in question is for the use of not to exceed 240 gallons per minute from a well located 2340 feet north and 1970 feet east from the southwest corner of Section 35, being within the NE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 35, Township 7 South, Range 4 West, W.M., with a beginning date of July 1944, for irrigation of:

3.0 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$
4.0 acres in the SE $\frac{1}{4}$ NW $\frac{1}{4}$
9.6 acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$
9.0 acres in the NW $\frac{1}{4}$ SE $\frac{1}{4}$

Section 35, Township 7 South, Range 4 West, W.M.,

and is described in the certificate of registration recorded in Volume 6, page 1338, Ground Water Registration Records.

That part of the claimed right for the use of not to exceed 60 gallons per minute from the described well for irrigation of 6.4 acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 35, Township 7 South, Range 4 West, W.M., and described in said certificate, is not in question in this proceeding.

NOW, THEREFORE, it is hereby ORDERED that the claim of a water right for the use of not to exceed 240 gallons per minute from a well located 2340 feet north and 1970 feet east from the southwest corner of Section 35, being within the NE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 35, Township 7 South, Range

4 West, W.M., with a beginning date of July 1944, for irrigation of:

3.0 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$

4.0 acres in the SE $\frac{1}{4}$ NW $\frac{1}{4}$


9.6 acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$

9.0 acres in the NW $\frac{1}{4}$ SE $\frac{1}{4}$

Section 35, Township 7 South, Range 4 West, W.M.,

is canceled.
