ORDER APPROVING
TRANSFER 5446

On March 5, 1984, an application was filed in the office of the Water Resources Director by Douglas County Water Resources Survey for approval of changes in use, place of use and points of diversion of water from Cow Creek, pursuant to the provisions of ORS 540.510 to 540.530.

The certificate recorded at page 48125, Volume 41, State Record of Water Right Certificates, in the name of Robert Sanders, describes a right for the use of not to exceed 0.15 cubic foot per second from Cow Creek, for irrigation of a certain 2.8 acres in NW 1/4 NE 1/4, 2.4 acres in SW 1/4 NE 1/4, 4.8 acres in NE 1/4 NW 1/4 and 2.2 acres in SE 1/4 NW 1/4, Section 34, Township 31 South, Range 4 West, WM, with a date of priority of May 18, 1972.

Water for the said right is diverted from a point located 390 feet North and 590 feet West from the South Quarter Corner of Section 27, being within the SE 1/4 SW 1/4 of Section 27, Township 31 South, Range 4 West, WM.

The applicant herein, owner of the lands above described, proposes to change the point of diversion from Cow Creek to four points located 2600 feet North and 1810 feet West from the Southeast Corner of Section 28, being within the NW 1/4 SE 1/4, Section 28, Township 31 South, Range 4 West, WM; 2940 feet North and 710 feet West from the Southeast Corner of Section 28, being within the SE 1/4 NE 1/4, Section 28, Township 31 South, Range 4 West, WM; 1540 feet North and 2050 feet East from the Southwest Corner of Section 27, being within the NE 1/4 SW 1/4, Section 27, Township 31 South, Range 4 West, WM; 3440 feet South and 6475 feet East from the Northwest Corner of Section 34, being within the NW 1/4 SW 1/4, Section 35, Township 31 South, Range 4 West, WM, and to change the use heretofore made to road construction in SW 1/4 NE 1/4, SE 1/4 NE 1/4, NE 1/4 NW 1/4, NW 1/4 NW 1/4, SE 1/4 NW 1/4, NE 1/4 SE 1/4, SE 1/4 SE 1/4, Section 27; NE 1/4 NE 1/4, SW 1/4 NE 1/4, SE 1/4 NE 1/4, SE 1/4 NW 1/4, NE 1/4 SW 1/4, Section 28; NE 1/4 NE 1/4, SE 1/4 NE 1/4, SE 1/4 SE 1/4, Section 34; SW 1/4 NW 1/4, SE 1/4 NW 1/4, NE 1/4 SW 1/4, NW 1/4 SW 1/4, SW 1/4 SW 1/4, Section 35, rock crushing and concrete making in SW 1/4 NE 1/4, SE 1/4 NE 1/4, NE 1/4 SE 1/4, NW 1/4 SE 1/4, Section 28, all in Township 31 South, Range 4 West, WM.

Notice of the application, pursuant to ORS 540.520(2), was published in the News-Review, a newspaper printed and having general circulation in Douglas County, Oregon, for a period of three weeks in the issues of June 20, 27 and July 4, 1984.

Gary L. Ball, Watermaster, has filed a statement to the effect that the proposed changes in use, place of use and points of diversion may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed changes in use, place of use and points of diversion may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the proposed changes in use, place of use and points of diversion are approved, without loss of priority.

It is FURTHER ORDERED that the quantity of water used for the proposed purposes shall not exceed 0.15 cubic foot per second, and shall be used only during the irrigation season of each year.

It is FURTHER ORDERED that the following provisions shall be effective when in the judgment of the Watermaster it becomes necessary to install headgates and measuring devices:


That the diversion works shall include an in line flow meter, a weir, or other suitable device for measuring the water to which the applicant is entitled;

That the type and plans of the measuring device be approved by the watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said watermaster.

It is FURTHER ORDERED that the construction work shall be completed and water used for the proposed purposes on or before October 1, 1985.

It is FURTHER ORDERED that the certificate recorded at page 48125, Volume 41, State Record of Water Right Certificates, is canceled; and upon proof satisfactory to the Water Resources Director of completion of works and beneficial use of water to the extent intended under the provisions of this order, a confirming certificate of water right shall be issued to the applicant herein.
