On March 31, 1986, an application was filed in the office of the Water Resources Director by Lewis Livestock Company for approval of changes in place of use and point of diversion of water from Umatilla River, pursuant to the provisions of ORS 540.510 to 540.530.

The certificate recorded at page 21304, Volume 15, State Record of Water Right Certificates, in the name of Lewis Livestock Co., describes a right for the use of not to exceed 0.437 cubic foot per second from Umatilla River, for irrigation of a certain 4.0 acres in NW 1/4 SW 1/4, Section 15, and 13.48 acres in NE 1/4 SE 1/4, Section 16, Township 2 North, Range 31 East, WM, with a date of priority of June 18, 1951.

Water for the said right is diverted from a point located within the NE 1/4 SE 1/4 of Section 16, Township 2 North, Range 31 East, WM.

The applicant herein, owner of the lands above described, proposes to add a second point of diversion at a point located 1010 feet South and 720 feet East from the West Quarter Corner of Section 15, being within the NW 1/4 SW 1/4 of Section 15, Township 2 North, Range 31 East, WM, and to change the place of use to irrigation of 2.3 acres in NW 1/4 SW 1/4, 7.58 acres in SW 1/4 SW 1/4, Section 15; 4.9 acres in NE 1/4 SE 1/4, 0.8 acre in SW 1/4 SE 1/4 and 1.9 acres in SE 1/4 SE 1/4, Section 16, Township 2 North, Range 31 East, WM.

Notice of the application, pursuant to ORS 540.520(2), was published in the East Oregonian, a newspaper having general circulation in the area in which the water right is located, for a period of three weeks in the issues of July 7, 14 and 21, 1986.

Michael F. Ladd, Watermaster, has filed a statement to the effect that the proposed changes in place of use and point of diversion may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed changes in place of use and point of diversion may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the proposed changes in place of use and point of diversion are approved, without loss of priority.

It is FURTHER ORDERED that the quantity of water diverted at the new point of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water available at the old point of diversion under the subject right, and shall not exceed 0.437 cubic foot per second.

It is FURTHER ORDERED that the following provisions shall be effective when in the judgment of the Watermaster it becomes necessary to install headqates and measuring devices:

> That the diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water to which the applicant is entitled;

> That the type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said Watermaster.

It is FURTHER ORDERED that the subject water right is hereby severed from the place of use described in Certificate 21304, and shall be beneficially used as authorized by this order on or before October 1, 1988.

It is FURTHER ORDERED that the certificate recorded at page 21304, Volume 15, State Record of Water Right Certificates, is canceled, and upon proof satisfactory to the Water Resources Director of completion of works and beneficial use of water to the extent intended under the provisions of this order, a confirming certificate of water right shall be issued to the applicant herein.
