ORDER APPROVING A CHANGE IN POINT OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6840 submitted by

ELIZABETH HITZ
13125 HITZ LANE
WOODBURN, OREGON 97071.

The right to be modified, as evidenced by a PORTION of Certificate 47000, was perfected under Permit G-5479 with a date of priority of JANUARY 3, 1975. The right allows the use of WELL 2, a tributary of the PUDDING RIVER BASIN, for IRRIGATION OF 38.0 ACRES. The right is limited to 0.24 cubic foot per second, if available at the original well; LOT 5 (NW $\frac{1}{4}$ SE $\frac{1}{4}$), SECTION 15, T 5 S, R 1 W, WM; 2720 FEET SOUTH FROM THE N $\frac{1}{4}$ CORNER OF SECTION 15, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2 $\frac{1}{2}$ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

LOT 3 (NE $\frac{1}{4}$ SW $\frac{1}{4}$)	1.5 ACRES
NW $\frac{1}{4}$ SW $\frac{1}{4}$	0.6 ACRE
SW $\frac{1}{4}$ SW $\frac{1}{4}$	12.3 ACRES
LOT 4 (SE $\frac{1}{4}$ SW $\frac{1}{4}$)	21.9 ACRES
SE $\frac{1}{4}$ SW $\frac{1}{4}$	0.2 ACRE

as projected within MAGOON DLC 57
SECTION 15

LOT 1 (NE $\frac{1}{4}$ NW $\frac{1}{4}$)	0.9 ACRE
NW $\frac{1}{4}$ NW $\frac{1}{4}$	0.6 ACRE

SECTION 22
TOWNSHIP 5 SOUTH, RANGE 1 WEST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to change the point of appropriation to:


SE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within MAGOON DLC 57, SECTION 15, T 5 S, R 1 W, WM; 4600 FEET SOUTH AND 550 FEET WEST FROM THE N $\frac{1}{4}$ CORNER OF SECTION 15.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 1995.
2. The quantity of water diverted at the new point of appropriation (well), together with the quantity of water appropriated at the old point of appropriation, shall not exceed the quantity of water available from the original point of appropriation.
3. When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
4. Water shall be acquired from the same aquifer as the original point of appropriation.

Certificate 47000 is cancelled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
