# **Findings of Fact**

- 1. Certificate 94345 was issued April 29, 2019 to describe the portion of the water right confirmed by Certificate 25885, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered April 29, 2019, recorded at Special Order Volume 112, Pages 1070 1082, approving Transfer Application T-12132.
- 2. Certificate 94345 contained a scrivener's error in the location description of the place of use. The certificate erroneously describes the place of use as:

3. The correct location is as follows:

1. Certificate 94345 is cancelled. Certificate 94413 is issued to correctly describe the water right NOT modified by the provisions of the order of the Water Resource Director approving Transfer Application T-12132 entered April 29, 2019, recorded at Special Order Volume 112, Pages 1070 – 1082.
