Protestant submitted a protest against the subject application on October 27, 2000 alleging the proposed transfer would injure existing water rights. Pursuant to Oregon Administrative Rules (OAR) 137-003-0580, the Department moved Hearing Officer Weisha Mize for a ruling on legal issues in this case, which, if granted, would result in denial of the protest and dismissal of the contested case proceeding. The parties presented argument on the motion at a pre-hearing conference held on March 1, 2001.

On March 7, 2001, the Hearing Officer Mize issued a Proposed Order, incorporated herein by reference, determining that there is no genuine issue as to any material fact relevant to resolution of the legal issue on which a decision is sought and that the Department is entitled to have its motion granted as a matter of law. OAR 137-003-0580(4). The Proposed Order proposed to grant the Department's motion, deny protestant's protest and dismiss the contested case proceeding. The Proposed Order provided until April 7, 200, to file exceptions. No exceptions were filed.

Protestants failed to raise any claim of injury as defined by OAR 690-15-005(15) and further failed to raise any issue or provide any basis for remedy within the Department's or the Hearing Officer's scope of authority. Consequently, I concur with the Hearing Officer's determinations.

FINAL ORDER

IT is ORDERED that the Department's motion is GRANTED.

It is FURTHER ORDERED that the protest against application T-8551 is DENIED, and the contested case proceeding in this matter is DISMISSED.
