FINDINGS OF FACT

1. On June 30, 2004, a Short-Term Lease Application, which proposed to lease a portion of certificates 10912, 10929, 80691, 42581, and 42582, for primary irrigation, and to lease certificates 42583 (a portion of), 27657 (all), and 3579 (a portion of), for supplemental irrigation, for instream purposes was submitted to the Department by:

- 2. The instream lease application included the required fees. The Department assigned this lease agreement number L-585.
- 3. The lease application includes the information required under OAR 690-077-0077(3). The Department provided notice of the lease application pursuant to OAR 690-077-0077(6) on July 6, 2004. No comments were received during the comment period.
- 4. On August 26, 2004, the Lessor amended the application to clarify the total number of acres to be leased instream under certificates 42581, 42582 and 42583. The rates and duties associated with each right, as requested in the application, have been modified to reflect this amendment. Also, on August 30, 2004, the Lessor requested to amend the application to clarify the correct duty and season of use for certificates 3579 and 27657. In addition, the Department has also made the following modification:

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order.

The portion of the rate that may be leased instream under certificate 42583 has been proportioned. This right allows the diversion of water at 1/80th Cubic Foot per Second (CFS)/acre. If water were to be applied to each acre authorized by this certificate, the maximum rate allowed by the right, being 71.31 CFS, would be exceeded. Therefore, the portion of this right that may be leased instream has been proportioned to prevent enlargement.

The rate described is a proportioned rate. Certificate 42583 does not allow the appropriation of the full rate per acre if all acres were being irrigated under the right. The rate at which water may be leased must then be proportioned. By first removing water that may be appropriated for primary irrigation, at a full rate of 1.548, 1/77.09th cfs/acre may be appropriated for supplemental irrigation if water were being applied to all irrigated acres allowed under this right. At this proportioned rate, 8.59 CFS may be appropriated for supplemental irrigation of 662.16 acres.

- 7. On August 30, 2004, the Lessor requested to amend the application to clarify that water under each right, except certificates 42581, 42582, and 42583, should be protected instream beginning May 1. Based upon continued evaluation and as a result in modifications made to the portions of the water rights to be leased in Finding 5, the Department finds that the following modifications are necessary to clarify the rates, volumes and time periods that water may be protected instream under each right:
 - a. At the rate requested, and given a duty of 3.0 AF/acre, water under certificate 27627 may be leased instream for a period of 120 days. The period requested, originally being 183 days, has been reduced.
 - b. The instream rates for certificates 42581, 42582 and 42583 have been modified to reflect the amendment made to the application by the Lessor to clarify the number of acres of irrigation being leased instream.
 - c. In addition, the instream supplemental rate for certificate 42583 has been reduced and proportioned as described in Finding 5. With the reduction in instream rate, the Department has also split the rate to clarify the amounts supplemental to each part of certificate 42582. The time period during which water may be protected instream has also been modified to match the time periods of the primary right.
 - d. The lease application requests to protect water under certificate 42582 from the point of diversion on each stream to Agency Lake. Fourmile Creek and Sevenmile Creek are both tributary to Agency Lake and water leased instream may be protected to Agency Lake. Annie Creek Slough is tributary to Sevenmile Creek. Normally, an instream use is maintained downstream from the point of diversion to the mouth of the source stream. However, if the quantity of water is measurable in the receiving stream, then an instream use may be maintained further downstream (OAR 690-077-0015 (7)). The Department has determined that the quantity of water to be leased in Annie Creek Slough is not measurable in Sevenmile Creek. Therefore the instream use in Annie Creek Slough may only maintained to the mouth of Annie Creek Slough.

9. The Department finds that certificate 3579 is supplemental to certificates 80691 and 10912. The portion of certificate 3579 being leased instream that is supplemental shall only be protected instream when necessary to make up a deficiency of the respective rates and duties of the primary supply under certificates 80691 and 10912 during the period for which water is being leased instream.

- 10. The Department finds that certificate 27657 is supplemental to certificates 80691, 10912, and 10929. The portion of certificate 27657 being leased instream that is supplemental shall only be protected instream when necessary to make up a deficiency of the respective rates and duties of the primary supply under certificates 80691, 10912, and 10929 during the period for which water is being leased instream.
- 11. The Department finds that certificate 42583 is supplemental to certificate 42582. The portion of certificate 42583 being leased instream that is supplemental shall only be protected instream when necessary to make up a deficiency of the respective rates and duties of the primary supply under certificate 42582 during the period for which water is being leased instream. A portion of certificate 42583 may also be protected instream to bring the rate and duty allowed under the primary right, certificate 42582, up to the full rate and duty allowed, being 1/50th CFS/acre and 5.0 AF/acre.
- 12. Based upon review of the application, comments received, information provided by the Department's Watermaster, and other available information, the Department finds that the lease, as modified, will not result in injury or enlargement.
- 13. The lease application requests to terminate the lease on October 1, 2004. Instream leases generally terminate on the last day of the season of use. The last day of the irrigation season for portions of certificates 42582 and 42583 is October 31. Therefore, the lease will terminate on October 31, 2004.

CONCLUSIONS OF LAW

The Department concludes that the lease, as modified above, will not result in injury or enlargement, OAR 690-077-0077.

ORDER

Therefore, it is ORDERED:

- 1. That the Short-Term Lease described herein is APPROVED.
- 2. The authorized place of use shall not be irrigated during the term of this lease.

4. Certificate 3579 is supplemental to certificates 80691 and 10912. The portion of certificate 3579 being leased instream that is supplemental shall only be protected instream when necessary to make up a deficiency of the respective rates and duties of the primary supply under certificates 80691 and 10912 during the period for which water is being leased instream.

- 5. Certificate 27657 is supplemental to certificates 80691, 10912, and 10929. The portion of certificate 27657 being leased instream that is supplemental shall only be protected instream when necessary to make up a deficiency of the respective rates and duties of the primary supply under certificates 80691, 10912, and 10929 during the period for which water is being leased instream.
- 6. Certificate 42583 is supplemental to certificate 42582. The portion of certificate 42583 being leased instream that is supplemental shall only be protected instream when necessary to make up a deficiency of the respective rates and duties of the primary supply under certificate 42582 during the period for which water is being leased instream. A portion of certificate 42583 may also be protected instream to bring the rate and duty allowed under the primary right, certificate 42582, up to the full rate and duty allowed, being 1/50th CFS/acre and 5.0 AF/acre.
- 7. The lease will terminate on October 31, 2004.
