FINAL ORDER

Authority

ORS 541.329 establishes the process by which a district may petition the Oregon Water Resources Commission for approval and acceptance of a district map identifying the location and use of the water rights within the district. ORS 541.327 authorizes the Walla Walla River Irrigation District to participate in the process described under ORS 541.325 to 541.331.

Findings of Fact

1. Pursuant to ORS 541.329,

submitted the Milton - Powell Ditch portion of a petition requesting approval and acceptance of district maps showing the location and use of water rights within the boundary of Walla Walla River Irrigation District (WWRID). The petition was submitted to the Oregon Water Resources Department (Department) on April 9, 2010, and included the required fees.

2. A summary of water rights affected by the petition is displayed in Table 1.
3. Walla Walla River Irrigation District petitioned the Department to modify 95 certificated water rights and four completed transfers. The water rights petitioned by WWRID authorize irrigation, supplemental irrigation domestic, stock and frost protection for a total of 748.98 acres. A description of the location of the certificated water rights, water use permits and completed transfers, modified by the petition are displayed in Tables 2 and 5.
4. The petitioned water rights and completed transfers allow the use of the waters of the Walla Walla River and its tributaries, including ditches and canals for irrigation. The point of diversion and point of re-diversion for the petitioned rights are as follows:

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

5. The certificates affected by the petition identify the source of water by various names including: Walla Walla River; Little Walla Walla River; and Ford Branch of Little Walla Walla River. A review of the identified sources reveals that the source of water for the relevant water rights is the Walla Walla River.
6. Certificates 13031 and 13010 authorize the use of water for domestic and stock purposes, in addition to irrigation. Walla Walla River Irrigation District has submitted to the Department a request to cancel the domestic portion of these water rights.
7. Tables 4 and 5 list the 1775.94 acres that were NOT modified by the petition (remaining rights).
8. The petitioner seeks certificates confirming the present place of use for the petitioned water rights. These rights authorize primary irrigation of 456.86 acres. The petitioned changes for these rights are listed in Table 3.
9. The petitioner also seeks certificates confirming the present place of use associated water rights include supplemental irrigation of 147.80 acres and frost protection for 27.0 acres. (See Table 5)
10. Table 4 describes the location and use of the irrigation water rights petitioned to be cancelled.
11. Table 5 provides a description of waste water for irrigation, supplemental irrigation, and frost protection water right certificates that are appurtenant to acreage described in Table 3. The petition includes a request to cancel 36.5 acres of supplemental irrigation and 1.1 acres of waste water for irrigation as listed in Table 5.
12. Some of the petitioned acreage have other appurtenant, layered water rights. These water right certificates and water use permits are shown in Table 5. The petition includes requests to diminish however affidavits from the landowners have not been received by the Department. Therefore, the Department is unable to resolve these layered water rights and will issue certificate consistent with the originating certificate. This results in multiple irrigation rights being located on the same land parcel. Multiple irrigation water rights are not cumulative. Such conflicts shall be resolved by the landowner or district at the time of any and all subsequent water right transactions. These conflicts may be resolved by the landowner or district canceling all or a portion of a water right, by diminishing all or a portion of a water right from irrigation to supplemental irrigation or by transferring the supplemental water right separately from the associated primary irrigation water right if another primary irrigation water right with similar reliability, consistent with OAR 690-380-2240(5). Additionally, in processing a transaction where multiple irrigation rights exist for the same land parcel, the Department shall designate the right with the oldest priority date as the primary irrigation right and diminish all other rights to supplemental irrigation unless the applicant specifies otherwise.
13. Transfer Application T-7641 was approved by Special Order Volume 53, Pages 1413 - 1415. The final order approved a change in place of use and point of diversion for Certificate 12710. On October 22, 2001, the Department received a Claim of Beneficial Use (CBU) for Transfer Application T-7641. The Department has evaluated the CBU and has determined

that satisfactory proof has been made on the inchoate portion of Transfer Application T-7641.

14. Transfer Application T-7642 was approved by Special Order Volume 53, Pages 1416 - 1418. The final order approved a change in place of use and point of diversion for a one acre portion of Certificate 13128. On October 22, 2001, the Department received a Claim of Beneficial Use (CBU) for Transfer Application T-7642. The Department has evaluated the CBU and has determined that satisfactory proof has been made on the inchoate portion of Transfer Application T-7642.
15. Transfer Application T-7643 was approved by Special Order Volume 53, Pages 1403 - 1406 and subsequently amended by Special Order Volume 53, Pages 1484 - 1485. The final order approved a change in place of use and combined portions of Certificates 50401 and 49482. On October 22, 2001, the Department received the Claim of Beneficial Use for Transfer Application T-7643. The Department has evaluated the CBU and has determined that satisfactory proof has been made on the inchoate portion of Transfer Application T-7643.
16. Transfer Application T-8626 was approved by Special Order Volume 58, Pages 363 - 367. The final order approved a change in place of use for Certificate 13030, a portion of Certificate 13052, and Certificate 13041. On May 31, 2005, the Department received a Claim of Beneficial Use for Transfer Application T-8626. The Department has evaluated the CBU and has determined that satisfactory proof has been made on the inchoate portion of Transfer Application T-8626.
17. Transfer Application T-7700 was approved on August 7, 2002 and recorded in Special Order Volume 56, Pages 803 – 823. This transfer affected a number of certificates involved in this petition. The Department was notified that the changes would not be completed as approved. The Department will issue an order (concurrently with this order) reverting the point of diversion to the last authorized point of diversion prior to the transfer and will include this transaction in the certificates issued as a result of this order approving WWRID's petition.
18. The Department reviewed the petition and maps submitted by WWRID. The Department's findings report is on file at the Department. Based on the review and evaluation, the Department finds:
 - a. WWRID is a "district" as defined in ORS 541.325(1).
 - b. WWRID filed its notice with the Department prior to June 30, 2004.
 - c. WWRID filed its petition and maps before June 30, 2010.
 - d. The petition and maps are in satisfactory form and certified by WWRID.
 - e. The maps are in an electronic format that meets the Department's standards.
 - f. The petition does not expand the water rights beyond the total of the rights of record.
 - g. WWRID's petition contained the elements required by ORS 541.329(2).
 - h. WWRID's petition does not contain more acres than allowed in ORS 541.329(3).
 - i. The acreage petitioned is within the limits established by ORS 541.331(4).
 - j. WWRID provided notice to affected water users, as required by ORS 541.329(4).
 - k. The proposed changes would not result in injury to existing water rights.

19. Appendix A of this order references the new certificates issued as a result of the approval of the petition.

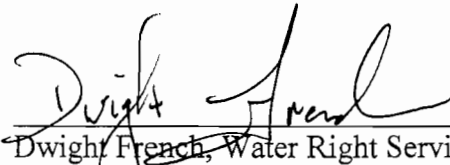
Conclusions of Law

Walla Walla River Irrigation District's petition and maps are consistent with the requirements of ORS 541.325 to ORS 541.331.

Now, therefore, it is ORDERED:

1. The Department approves Walla Walla River Irrigation District's petition and maps of water rights.
2. The Department cancels certificates for primary irrigation for the water rights listed in Table 2 and shall issue new confirming water right certificates conforming to the approved petition as listed in Table 3.
3. The Department cancels the domestic portion of the certificates identified in Finding of Fact #6.
4. The Department shall issue remaining right certificates for the portions of the water rights not modified by the petition as shown in Table 1, except for the unmodified portions of Transfer Applications T-7642 and T-7643. The Department will issue confirming rights for the unmodified portions of these transfers based on the evaluated Claims of Beneficial Use.
5. The Department shall cancel those portions of the certificates listed on Table 4.
6. The Department shall cancel the portions of the water rights identified in Table 5, and issue new confirming water right certificates conforming to the approved petition for supplemental irrigation acres and remaining right certificates for the portions of the water rights not modified by the petition.
7. The Department shall diminish the relevant portions of the water rights identified in Table 5.
8. The Department shall issue remaining rights for the portion of Certificate 84160 not modified by the petition, as shown in Table 5.
9. The Department shall cancel the frost protection rights identified in Table 5 and issue new confirming water right certificates conforming to the approved petition consistent with Table 5.
10. The Department shall issue confirming certificates on completed transfers T-7641, T-7642, T-7643, and T-8626 consistent with Table 3.
11. The Department shall issue new certificates retaining the appropriate conditions, limitations, seasons of use, priority dates and rates for the water rights affected.
