ORDER APPROVING A CHANGE IN PLACE OF USE

Pursuant to ORS 537.705 and ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFERS 6579 and 6580 submitted by

RICK SONNEN 19155 ARBOR GROVE ROAD NE WOODBURN, OREGON 97071.

The first right to be modified, as evidenced by a PORTION of Certificate 36319, was perfected under Permit G-3645 with a date of priority of APRIL 7, 1967. The right allows the use of A WELL, a tributary of CASE CREEK BASIN, for IRRIGATION OF 25.0 ACRES. The right is limited to 0.21 cubic foot per second, if available at the original well; SW\(\frac{1}{3}\) SW\(\frac{1}{3}\), AS PROJECTED WITHIN HUNT DLC 52, SECTION 25, T 4 S, R 2 W, W.M.; 200 FEET NORTH AND 1370 FEET WEST FROM THE SE CORNER OF JACKSON DLC 51, or its equivalent in case of rotation, measured at the well.

The other right to be modified, as evidenced by a PORTION of Certificate 39444 was perfected under Permit 35772 with a date of priority of DECEMBER 4, 1970. The right allows the use of CASE CREEK, a tributary of WILLAMETTE RIVER, for SUPPLEMENTAL IRRIGATION OF 25.0 ACRES. This right is limited to 0.31 cubic foot per second, if available at the authorized point of diversion: SE\ SE\, AS PROJECTED WITHIN HUNT DLC 52, SECTION 26, T 4 S, R 2 W, W.M.; 590 FEET NORTH AND 3390 FEET WEST FROM THE SE CORNER OF JACKSON DLC 51, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation under these rights is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2½ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

SW½ SE½ 4.8 ACRES SE½ SE½ 5.2 ACRES SECTION 25

NE NE NE S.4 ACRES
NW NE NE S.6 ACRES

SECTION 36

ALL AS PROJECTED WITHIN HUNT DLC 52 TOWNSHIP 4 SOUTH, RANGE 2 WEST, W.M.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to change the place of use to:

SW\(\frac{1}{3}\) SW\(\frac{1}{3}\) 6.6 ACRES SECTION 25

NE 1 NW 1 5.1 ACRES NW 1 NW 1 13.3 ACRES

SECTION 36

ALL AS PROJECTED WITHIN HUNT DLC 52 TOWNSHIP 4 SOUTH, RANGE 2 WEST, W.M.

THIS CHANGE TO EXISTING WATER RIGHTS MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 1993.
- The former place of use shall no longer be irrigated as a part of these water rights.

Certificates 39444 and 36319 are cancelled. New certificates will be issued to confirm those portions of these rights NOT involved in these transfers. When satisfactory proof of the completed change is received, new certificates confirming these water rights will be issued.
