O R D E R
APPROVING APPLICATION

On July 8, 1939, the Wolf Run Water Users Association filed an application for approval of a change in point of diversion of water from Tamarack Creek.

Certificates of water right, recorded at Pages 2353, 2358, and 2359, Volume 3, State Record of Water Right Certificates, were issued to the Wolf Run Water Users Association, confirming a right to the use of 5.11 cubic feet per second of the waters of Tamarack Creek, springs and gulch, and Eight Mile Creek for domestic and stock purposes and for the irrigation of 385 acres in Sections 3, 4, 5, and 8, Township 2 South, Range 12 East, W. M.; Sections 25, 26, 33, 34, 35, and 36, Township 1 South, Range 12 East, W. M., and Sections 29, 30, and 31, Township 1 South, Range 13 East, W. M., with a date of priority of May 3, 1909.

The applicant herein proposes to change the present point of diversion of Tamarack Creek located at a point north $54^{\circ} 45'$ west 1,340 feet from the southeast corner of Section 11, Township 2 South, Range 11 East, W. M., to a point up-stream and to be located at a point approximately 1,300 feet north of the southeast corner of Section 8, Township 2 South, Range 11 East, W. M.

Notice by publication as provided by Section 47-712, Oregon Code 1935 Supplement, was given in The Dufur Dispatch, a newspaper of general circulation in Wasco County, for a period of at least three weeks and not less than one publication each week; namely, July 20 and 27 and August 3 and 10, 1939.

No objections having been filed, it appears that such change in point of diversion of water may be made without injury to existing rights.

NOW, THEREFORE, it hereby is ORDERED that the proposed change in point of diversion of water from Tamarack Creek, to-wit: From a point located north $54^{\circ} 45'$ west 1,840 feet from the southeast corner of Section 11, Township 2 South, Range 11 East, W. M., to a point up-stream and to be located at a point approximately 1,300 feet north of the southeast corner of Section 8, Township 2 South, Range 11 East, W. M., with a date of priority of May 3, 1909, be and the same hereby is approved.
