## ORDER APPROVING A CHANGE IN PLACE OF USE

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6979 submitted by

POTLATCH CORPORATION HOMESTEAD ROAD BOARDMAN, OREGON 97818.

The right to be modified, as evidenced by a PORTION of Certificate 52102, was perfected under Permit 37150 with a date of priority of JULY 25, 1973. The right allows the use of the COLUMBIA RIVER, a tributary of the PACIFIC OCEAN, for IRRIGATION OF 641.4 ACRES. This right is limited to 16.03 cubic foot per second, provided the total quantity diverted under the right perfected under Permit 37150 does not exceed 140.1 cfs, if available at the authorized point of diversion: LOT 7 (NE¼ NW¼), SECTION 2, T 4 N, R 25 E, WM; 150 FEET SOUTH AND 2990 FEET WEST FROM THE NE CORNER OF SECTION 2, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation under this right is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and  $4\frac{1}{2}$  acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described.

The location of the place of use will be 8 feet wide strips, with 2 feet wide strips between the irrigated strips. The applicant proposes to irrigate, with a drip irrigation system, only the 8 feet wide strips. The applicant proposes to prove the 2 feet wide strips do not receive water.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- The proposed change shall be completed on or before October 1, 1995.
- The water user shall operate a soil moisture monitoring system that will demonstrate water is being delivered only to lands having a water right. Such a system shall include, but not be limited to, data collection points within the strips having water rights, within the strips not having water rights, and within an area near the irrigated area to collect background data. The monitoring system shall also receive reasonably current information from a weather data collection and reporting system with a data collection site in the vicinity of this project. The monitoring system will be extensive enough to insure conditions are the same throughout the entire project, regardless of any crop rotation system.

The monitoring system shall have a capability of displaying and reporting current conditions. The information, both current and historical, shall be made available to the Watermaster upon request. The Watermaster may monitor the accuracy of the monitoring system as needed.

If the applicant is not successful in proving the 2 feet wide strips do not receive water, this condition will terminate. If the applicant is successful, this condition will continue in force. 3. The water user or improvement district shall install a meter or other suitable measuring device at the point of diversion, as approved by the Watermaster. The water user or improvement district shall maintain the meter or measuring device in good working order, shall keep a complete record of the amount of water used each month and shall submit a report which includes the recorded water use measurements to the Department annually or more frequently as may be required by the Watermaster. Further, the Watermaster may require the water user to report general water use information, including the place and nature of use of water under the order.

The water user or improvement district shall allow the Watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the Watermaster shall request access upon reasonable notice.

4. The former place of use shall no longer be irrigated as a part of this water right.

Certificate 52102 is cancelled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
