ORDER APPROVING AN ADDITIONAL POINT OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 9016 submitted by

TIMOTHY DAHLE
5070 CHERRY HTS. ROAD
THE DALLES, OREGON 97058.

The right to be modified, as evidenced by a PORTION of Certificate 50552, was perfected under Permit G-6778 with a date of priority of APRIL 27, 1976. The right allows the use of WELL 1, within the RAMSEY CREEK BASIN, for SUPPLEMENTAL IRRIGATION OF 89.8 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.45 cubic foot per second, if available at the original well; SW¼ SE¼, SECTION 31, T 1 S, R 13 E, W.M.; 430 FEET NORTH AND 3460 FEET EAST FROM SW CORNER OF SECTION 31, or its equivalent in case of rotation, measured at the well.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005, you may either petition for judicial review or petition the Director for reconsideration of this order.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

NW $\frac{1}{4}$ SE $\frac{1}{4}$ 9.3 ACRES
SECTION 31

TOWNSHIP 1 SOUTH, RANGE 13 EAST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to add an additional point of appropriation to:

SE $\frac{1}{4}$ SE $\frac{1}{4}$, SECTION 36, TOWNSHIP 1 SOUTH, RANGE 12 EAST, W.M.; 338 FEET NORTH FROM SW CORNER SECTION 31.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 2005.
2. The quantity of water diverted at the new point of appropriation (well), together with the quantity diverted at the old point of appropriation, shall not exceed the quantity of water authorized by this right.
3. The water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
4. Water shall be acquired from the same aquifer as the original point of appropriation.

Certificate 50552 is canceled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
