ORDER APPROVING APPLICATION

On September 10, 1934, Scott and Roy Redfearn filed an application for the approval of a change in point of diversion of water from the West Crockett Branch of Little Walla Walla River.

By decree of the court for Umatilla County dated May 16, 1932, a water right was recognized in the name of H. M. Connell for the irrigation of 3.0 acres with a date of priority of 1890, 1.36 acres with date of priority of 1898, 3.5 acres with date of priority of 1903 and 1.98 acres with date of priority of 1908, all of said lands being within the SW $\frac{1}{4}$ NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 35, Township 6 North, Range 35 East, W.M.

The applicants herein, owners of the above described lands, propose to change the present point of diversion from West Crockett Branch of Little Walla Walla River which is located 947 feet south and 950 feet west from the southeast corner of the NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 35, Twp. 6 N., R. 35 East, W.M., to a point on the East Crockett Branch of Little Walla Walla River 30 feet north and 125 feet west from the southeast corner of the NE $\frac{1}{4}$ NE $\frac{1}{4}$ Section 35, Twp. 6 N., R. 35 East, W.M.. It appears that notice for publication as provided by Section 47-712 Oregon Code 1930, was published in the Freewater Times once each week for three successive weeks in the issues of October 26, November 2 and 9, 1934.

It further appears that no objections have been filed and that such change can be made without injury to existing rights,
