STATEMENT OF FACTS

- 1. Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, the Water Resources Director signed an order approving T-6341 for three additional points of appropriation. The order was signed on January 4, 1991, and recorded in Special Order Volume 45, at page 4.
- 2. The right subject to transfer under T-6341, and modified by the order approving the transfer, was perfected by performance under Permit G-10570 with a date of priority of July 29, 1985. Perfected by performance means the Director had received satisfactory proof that the right had been perfected in accordance with the permit, but a water right certificate had not been issued.
- 3. On August 19, 1996, The Department issued Certificate 72471 for the perfection of the right developed under Permit G-10570. Certificate 72471 confirms the right to use two wells for irrigation and frost control on 20.5 acres.
- 4. On the same date, August 19, 1996, the Department issued Certificate 72473 confirming the three additional points of appropriation under T-6341. This certificate duplicates Certificate 72471 for irrigation and frost control of 20.5 acres, but confirms the use of five wells and contains conditions upon the use of water imposed by the order approving T-6341.
- 5. The Department erred by issuing Certificate 72471. The right confirmed by Certificate 72471, evidenced by the perfection of Permit G-10570, had previously been modified by the order approving T-6341. Thus, Certificate 72471 should not have been issued. Regardless,

the issuance of Certificate 72473 confirming the changes authorized by T-6341 supersedes Certificate 72471.

6. Consistent with ORS 540.530(2)(a), and so as to clarify the water right record for the right developed under Permit G-10570, Certificate 72471 should be canceled and the records updated to reflect that Certificate 72473 supersedes Certificate 72471.

CONCLUSIONS OF LAW

Pursuant to ORS 540.530(2)(a), if a certificate covering the water right has been previously issued, upon proper completion of the authorized changes under the transfer, the Director shall cancel the previous certificate and issue a new certificate.

ORDER

IT IS ORDERED:

- 1. Water Right Certificate 72471 is hereby canceled.
- 2. The Department shall clarify the water right record to show that Certificate 72473 supersedes Certificate 72471.
