ORDER APPROVING A CHANGE IN POINT OF DIVERSION AND PLACE OF USE

Pursuant to ORS 540.510 TO 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves TRANSFER 6279 submitted by

NORTH UMPQUA BIBLE FELLOWSHIP
1547 WILD RIVER DR
ROSEBURG, OREGON 97470

to use the waters of the NORTH UMPQUA RIVER, a tributary of the UMPQUA RIVER, for the purpose of IRRIGATING 2.6 ACRES.

The right to be transferred, as evidenced by certificate 29351, was perfected under Permit 25203, with a date of priority of September 26, 1957. This right is limited to 0.035 cubic foot per second, if available at the original point of diversion: NE 1/4 SW 1/4, AS PROJECTED WITHIN DLC 40, SECTION 14, T 26 S, R 4 W, W.M.; 2235 FEET NORTH AND 3500 FEET WEST FROM THE SE CORNER OF SECTION 14, or its equivalent in case of rotation, measured at the point of diversion from the source.

The new point of diversion is located as follows:

NE 1/4 SW 1/4, AS PROJECTED WITHIN DLC 40, SECTION 14,
T 26 S, R 4 W, W.M.; 2170 FEET NORTH AND 3160 FEET WEST FROM THE SE
CORNER OF SECTION 14.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the new place of use is as follows:

SE 1/4 SW 1/4 2.6 ACRES
AS PROJECTED WITHIN DLC 40
SECTION 14
TOWNSHIP 26 SOUTH, RANGE 4 WEST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.


THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 1991.
2. The quantity of water diverted at the new point of diversion shall not exceed the quantity of water available at the original point of diversion.
3. When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
4. The following former place of use shall no longer be irrigated as a part of this water right:

SE 1/4 SW 1/4 2.6 ACRES
AS PROJECTED WITHIN DLC 40
SECTION 14
TOWNSHIP 26 SOUTH, RANGE 4 WEST, W.M.

Certificate 29351 is canceled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
