**Findings of Fact**

1. On October 18, 2017, the Department signed a final order approving Transfer Application T-12605, which was mailed on October 27, 2017, and recorded in Special Order Volume 107, Pages 5-12, involving Certificates 82491, 82490, and Permits S-54980 and G-15586.
2. The final order approving the transfer contained a scrivener's error in the township in the proposed place of use of four parcels. The order approved the following parcels as indicated in the table below:

3. Consistent with the proposed place of use table and map submitted with the transfer application for Transfer T-12605, the township for the proposed place of use for the four parcels should have been listed in the final order as follows (correction shown in **bold**):

- On May 23, 2019, the Department issued a final order making a Determination of Satisfactory Proof for completion of permanent district Transfer T-12605 (DSP order) which was recorded in Special Order Volume 113, Pages 129-133. The DSP order failed to correct the error described in Finding of Fact #2 (corrected in Finding of Fact #3), above.
- This correcting order is being issued to correct the scrivener's error in the DSP order recorded in Special Order Volume 113, Pages 129-133.
- Consistent with the final proof map in the Claim of Beneficial use for Transfer T-12605, the place of use for the parcel described in Tables 1 and 2, Rows 12-15, in the DSP order issued May 23, 2019, , should be confirmed as follows (correction shown in **bold**):


