ORDER APPROVING AN ADDITIONAL POINT OF DIVERSION

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 8956 submitted by

STEVE AND MARY WALPORT 2308 UPPER APPLEGATE ROAD JACKSONVILLE, OREGON 97530.

The first right to be modified was confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County as evidenced by a PORTION of Certificate 16407. The decree is recorded in the Order Record of the Water Resources Director in Volume 4, at Page 1. The date of priority is SEPTEMBER 1, 1857.

The right allows the use of LITTLE APPLEGATE RIVER, a tributary of APPLEGATE RIVER, for IRRIGATION OF 0.5 ACRES and STOCK USE. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.0125 cubic foot per second, if available at the authorized point of diversion: FARMERS DITCH-NE% NE%, SECTION 14, TOWNSHIP 39 SOUTH, RANGE 3 WEST, W.M., or its equivalent in case of rotation, measured at the point of diversion from the source.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order.

The authorized place of use is located as follows:

NE% SW% 0.5 ACRES SECTION 3 TOWNSHIP 39 SOUTH, RANGE 3 WEST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.

The applicant proposes an additional point of diversion:

NW% SW%, SECTION 3, TOWNSHIP 39 SOUTH, RANGE 3 WEST, W.M.; 1630 FEET WEST AND 100 FEET NORTH OF THE CENTER OF SECTION 3.

The second right to be modified was confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County as evidenced by a PORTION of Certificate 60559. The decree is recorded in the Order Record of the Water Resources Director in Volume 4, at Page 1. The date of priority is SEPTEMBER, 1, 1857.

The right allows the use of LITTLE APPLEGATE RIVER, a tributary of APPLEGATE RIVER, for IRRIGATION OF 0.5 ACRES AND STOCK USE. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.01 cubic foot per second, if available at the authorized point of diversion: NE% NE%, SECTION 14, T 39 S, R 3 W, W.M.; FARMERS DITCH, 350 FEET SOUTH, AND 900 FEET WEST FROM NE CORNER OF SECTION 14, or its equivalent in case of rotation, measured at the point of diversion from the source.

The authorized place of use is located as follows:

SE% NW% 0.5 ACRES

SECTION 3

TOWNSHIP 39 SOUTH, RANGE 3 WEST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.

The applicant proposes an additional point of diversion:

NW% SW%, SECTION 3, TOWNSHIP 39 SOUTH, RANGE 3 WEST, W.M.; 1630 FEET WEST AND 100 FEET SOUTH OF THE CENTER OF SECTION 3.

Special Order Volume 1 Page 256 incorrectly listed the both authorized point of diversion and the proposed point of diversion for the Farmers Ditch in TOWNSHIP 36 SOUTH, the correct location is in TOWNSHIP 39 SOUTH. This order corrects that scrivener error.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 2005.
- 2. The quantity of water diverted at the new point of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water lawfully available at the original point of diversion.
- 3. When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 4. Water shall be acquired from the same surface water source as the original point of diversion.

- 5. Upon submittal of the Claim of Beneficial Use for this transfer the current landowner of the property to which this water right is appurtenant shall submit a time limited transfer for the entire water right described in this transfer. Further more, the time limited transfer shall request a temporary character of use change from irrigation to instream use for fisheries enhancement, and that the reach shall be defined from the original point of diversion to the mouth of the Little Applegate River.
- 6. The irrigation system capacity shall be designed not to exceed the rate for the number of acres described by this order.
- 7. The water user shall install and maintain a fish screen or fish by-pass device. The type and plans of the screen or by-pass device must be approved by the Oregon Department of Fish and Wildlife prior to beginning of construction and shall be installed under the supervision of the Department of Fish and Wildlife.

The water user may participate in the Oregon Department of Fish and Wildlife's cost sharing program for installation of screening and by-pass devices in accordance with ORS 540.525.

Certificate 16407 is canceled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
